| 8 | Be it enacted by the Legislature of Louisiana: |
| 9 | Section 1. R.S. 32:57(J) and 268 are hereby enacted to read as follows: |
| 10 | §57. Penalties; alternatives to citation |

| 12 | J. If a person operating a motor vehicle violates the provisions of this |
| 13 | Chapter while on the Atchafalaya Basin Bridge, the fine shall be two times the |
| 14 | standard fine imposed. For purposes of this Subsection, the Atchafalaya Basin |
| 15 | Bridge shall mean the Atchafalaya Elevated Expressway designated by Act No. |
| 16 | 793 of the 1989 Regular Session of the Legislature as the Louisiana Airborne |
| 17 | Memorial Bridge. |

2 §268. Atchafalaya Basin Bridge; highway safety corridor; camera usage; signs A.(1) The legislature finds and declares that the Atchafalaya Basin 3 Bridge shall be identified as a highway safety corridor based on data analytics 4 5 that have identified this segment of highway as a high collision crash zone resulting in severe injury and fatality due primarily to driver behavior such as 6 7 speeding, aggressive driving, impairment, and distracted driving. 8 Notwithstanding any provision of law to the contrary, including R.S. 32:267 et 9 seq., the Department of Transportation and Development shall take all steps 10 necessary to implement the provisions of this Section. 11 (2) The legislature further finds and declares that the department shall implement measures to reduce safety risks to both law enforcement and 12 13 individuals driving across the Atchafalaya Basin Bridge including but not 14 limited to the implementation of camera safety devices and installation of 15 additional signage. (3) For purposes of implementation of this Section, the Atchafalaya Basin 16 17 Bridge shall mean the Atchafalaya Elevated Expressway designated by Act No. 793 of the 1989 Regular Session of the Legislature as the Louisiana Airborne 18 19 Memorial Bridge. 20 B.(1) The department shall install camera safety devices on the 21 Atchafalaya Basin Bridge. The department may consult with the Safety 22 Corridor Advisory Group to determine the quantity, placement, duration of use, and operation of the cameras. The department may monitor the cameras 23 24 or may contract with a third-party to monitor the cameras. The department may determine whether the cameras should be utilized continuously or only 25 26 during certain hours. 27 (2) The department shall establish a process for identification of motor 28 vehicles traveling in excess of the posted speed limit, issuance of warnings and

citations, and collection of fines.

| 4 | C. The department shall place the following signs, in compliance with the |

| 18 | eastbound portion of the bridge and six sets of "Trucks Right Lane Only" signs |
| 19 | equally spaced on the westbound portion of the bridge. |
| 20 | D. Nothing in this Section shall be construed as precluding any police |
| 21 | officer from enforcing traffic laws on the Atchafalaya Basin Bridge. However, |
| 22 | no person shall be subject to a citation issued pursuant to this Section if a |

| 24 | E.(1) There is hereby created in the state treasury a special fund to be |

| 27 | (2) Any monies collected as fines pursuant to R.S. 32:57(J), as a result of |
| 28 | traffic camera safety device data, shall be deposited into the fund. |

provisions of this Section. Thereafter, at the conclusion of each fiscal year, any unexpended monies in the fund shall be divided equally between the parishes of Iberville and St. Martin and shall be remitted to entities or organizations within each parish in the same proportions as fines collected by the parishes when traffic violations are issued by a law enforcement officer.

(4) All unexpended and unencumbered monies in the fund at the end of

the fiscal year shall remain in the fund.

Cortez

<u>Present law</u> provides relative to the La. Highway Regulatory Act, which includes provisions relating to speed limits and driving on the right side of the road, overtaking, and passing.

<u>Present law</u> provides for penalties for a violation of the La. Highway Regulatory Act with the first offense being a fine of not more than \$175 or imprisonment of not more than 30 days, or both, unless otherwise provided by law. A subsequent violation will result in a fine of not more than \$500 or imprisonment for not more than 90 days, or both.

<u>Proposed law</u> retains <u>present law</u> and provides that if a person operating a motor vehicle violates the provisions of <u>present law</u> while on the Atchafalaya Basin Bridge, the fine shall be two times the standard fine imposed.

<u>Proposed law</u> provides that the Atchafalaya Basin Bridge means the Atchafalaya Elevated Expressway designated by Act 793 of 1989 as the Louisiana Airborne Memorial Bridge.

<u>Proposed law</u> provides legislative intent designating the Atchafalaya Basin Bridge as a highway safety corridor and directs DOTD to take all steps necessary to implement <u>proposed law</u> including but not limited to the implementation of camera safety devices and installation of additional signage.

<u>Proposed law</u> authorizes DOTD to install camera safety devices on the bridge, provides certain parameters, and provides for rulemaking.

<u>Proposed law</u> provides for signage on the bridge to include speed limit signs, "Trucks Right Lane Only" signs, and "Safety Corridor, Fines Doubled for Speeding and Other Violations" signs.

Proposed law provides for the number and placement of the signs.

<u>Proposed law</u> provides that the signs are in compliance with the Manual of Uniform Traffic Control Devices.

<u>Proposed law</u> provides that no person shall be subject to a citation issued pursuant to <u>proposed law</u> if a citation for the same offense was also issued by a police officer.

<u>Proposed law</u> provides for the creation of the Atchafalaya Basin Bridge Safety Fund and for the management of money in the fund. Further provides for monies from the fund to be used to cover expenditures of the department in setting up required signage and cameras. Changes pro rata distribution from the fund to the parishes to proportional distribution based on the civil fines attributable to each parish.

<u>Proposed law</u> requires that, subject to legislative appropriation, monies in the fund be used first to fund the department's expenditures necessary to implement <u>proposed law</u> and that thereafter, at the conclusion of each fiscal year, any unexpended monies in the fund shall be divided equally between the parishes of Iberville and St. Martin to be remitted to entities or organizations within each parish in the same proportions as fines collected by the parishes when traffic violations are issued by a law enforcement officer.

Summary of Amendments Adopted by Senate

<u>Committee Amendments Proposed by Senate Committee on Transportation,</u> <u>Highways, and Public Works to the original bill</u>

- 1. Reduces the fine from five times the standard amount to two times.
- 2. Clarifies that the Atchafalaya Basin Bridge means the Atchafalaya Elevated Expressway designated by Act 793 of 1989 as the Louisiana Airborne Memorial Bridge.
- 3. Provides legislative intent.
- 4. Requires DOTD to implement safety measures including cameras and increased signage.
- 5. Provides that no person shall be subject to a citation issued from a camera if they were also issued a citation for the same offense by a police officer.
- 6. Creates the Atchafalaya Basin Bridge Safety Fund.

<u>Committee Amendments Proposed by Senate Committee on Finance to the engrossed bill</u>

- 1. Provides for monies from the fund to be used to cover expenditures of the department in setting up required signage and cameras.
- 2. Changes pro rata distribution from the fund to the parishes to proportional distribution based on the civil fines attributable to each parish.

Senate Floor Amendments to reengrossed bill

1. Adds provisions for use and distribution of monies in the Fund.
