HOUSE RESOLUTION NO. 130

CURRICULA/DRIVER ED: Urges and requests the office of motor vehicles include information about organ, eye, and tissue donation in driver education training

A RESOLUTION

2	To urge and request the Department of Public Safety and Corrections, office of motor
3	vehicles, to include in all driver education programs classroom or educational setting
4	information about organ, eye, and tissue donation.
5	WHEREAS, a person can register as an organ, eye, and tissue donor in the state of
6	Louisiana by saying 'yes' when applying for a driver's license or state identification card or
7	by signing up on the Louisiana donor registry; and
8	WHEREAS, over two thousand people are awaiting life-saving organ transplants in
9	the state of Louisiana; and
0	WHEREAS, over fifty people can benefit from one donor's tissue donation; and
1	WHEREAS, two people can have sight restored from one eye donor; and
12	WHEREAS, the lack of knowledge about organ donation is one of the main factors
13	leading to the shortage of organ donation; and
4	WHEREAS, there is a growing need to educate and ensure potential donors have the
15	information they need to make sound decisions; and
16	WHEREAS, people often disqualify themselves as potential donors by citing
17	misconceptions; and
18	WHEREAS, the office of motor vehicles certifies other driver education and training
9	courses; and
20	WHEREAS, according to the office of motor vehicles, over four million persons are
21	recorded as having Class "E" driver's license; and

1	WHEREAS, every year, tens of thousands of young people apply for their first
2	driver's license or state identification card; and
3	WHEREAS, according to the office of motor vehicles, seven hundred seventy
4	thousand one hundred twenty-six Class "E" driver licenses were issued this past year; and
5	WHEREAS, Aliye Ringe, a then resident of Central, Louisiana made the selfless
6	decision at the age of sixteen when obtaining her driver's license to register as an organ
7	donor; and
8	WHEREAS, Aliye Ringe was involved in a fatal crash on December 22, 2021; and
9	WHEREAS, Aliye Ringe's decision to become an organ donor saved the lives of five
10	persons on Christmas day; and
11	WHEREAS, the opportunity to register as an organ, eye, and tissue donor should be
12	included in all driver education and training programs to afford a potential donor a chance
13	to save and heal the lives of others after death; and
14	WHEREAS, each day, approximately seventeen people die waiting for a lifesaving
15	organ transplant and a new name is added to the transplant waiting list every nine minutes.
16	THEREFORE, BE IT RESOLVED that the House of Representatives of the
17	Legislature of Louisiana does hereby urge and request the Department of Public Safety and
18	Corrections, office of motor vehicles, to include in all driver education programs classroom
19	or educational setting information about organ, eye, and tissue donation.
20	BE IT FURTHER RESOLVED that the Department of Public Safety and
21	Corrections, office of motor vehicles, shall submit a written report of its findings and
22	recommendations to the House Committee on Transportation, Highways and Public Works
23	no later than March 1, 2023.
24	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
25	secretary of the Department of Public Safety and Corrections, office of motor vehicles, and
26	to the family of Aliye Ringe.
