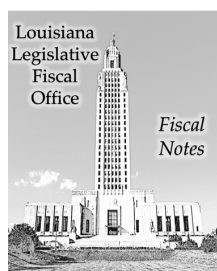

Provides relative to rule making procedure

Proposed law adds to present law regarding procedures for adoption of rules that rules be transmitted to each member of the legislature via electronic mail no later than ten (10) days after the date the proposed rule change is submitted to the Louisiana Register. Proposed law provides that under the emergency rulemaking provisions, each member of the legislature via electronic mail shall receive the proposed rule changer no later than ten (10) days after it is submitted to the Louisiana Register.
