- 4 On page 3, after line 16, add the following:
 - (1) "Health coverage plan" means any hospital, health, or medical expense insurance policy, hospital or medical service contract, employee welfare benefit plan, contract or agreement with a health maintenance organization or a preferred provider organization, health and accident insurance policy, or any other insurance contract of this type. "Health coverage plan" does not include a plan providing coverage for excepted benefits as defined in R.S. 22:1061, limited benefit health insurance plans, short-term policies that have a term of less than twelve months, nor any plan offered through the office of group benefits.

"C. For purposes of this Section, the following terms apply:

- (2) "Iatrogenic infertility" means an impairment of fertility caused directly
 or indirectly by surgery, radiation, chemotherapy, or other medical treatment.
- 16(3) "Medical treatment that may directly or indirectly cause iatrogenic17infertility" means medical treatment with a potential side effect of impaired fertility18as established by the American Society of Clinical Oncology or the American19Society for Reproductive Medicine.
- 20 (4) "Standard fertility preservation services" means procedures to preserve
 21 fertility that are consistent with established medical practices or professional
 22 guidelines published by the American Society of Clinical Oncology or the American
 23 Society for Reproductive Medicine.
- Section 2. This Act shall be known and may be cited as "The Medically Necessary
 Fertility Preservation Act".
- 26 Section 3.(A) This Act shall become effective on January 1, 2024.
- (B) This Act shall apply to any new policy, contract, or health coverage plan issued,
 delivered, amended, or renewed in this state on or after January 1, 2023."
