## **EXPENDITURE EXPLANATION**

The Louisiana Public Defender Board (LPDB) may experience increased expenditures to enter into a contract with the University of Louisiana at Monroe (ULM). ULM provided an initial estimate of \$253,000, however actual amounts are indeterminable and are subject to the scope and deliverables of the final contract approved by the LPDB. For illustrative purposes, the LPDB spent \$234,360 for training purposes in FY 21. The legislation requires any contract or contracts formed to use existing funds appropriated by the legislature.
