

SENATE BILL NO. 178

BY SENATOR FIELDS

1 AN ACT

2 To enact R.S. 17:5105, relative to the Taylor Opportunity Program for Students; to provide  
3 relative to eligibility for awards; to waive or modify certain eligibility provisions for  
4 certain students in response to circumstances related to certain natural disasters and  
5 certain public health emergencies; to authorize the administering agency to waive  
6 eligibility requirements; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 17:5105 is hereby enacted to read as follows:

9 **§5105. Eligibility for students impacted by Hurricane Ida**

10 **A. The legislature finds that due to the effects of Hurricane Ida, it is in**  
11 **the best interest of the people of the state that initial and continuing eligibility**  
12 **requirements established in Part I of this Chapter for awards pursuant to the**  
13 **Taylor Opportunity Program for Students be modified as provided by this**  
14 **Section.**

15 **B. Provisions of this Chapter that provide for initial eligibility are**  
16 **modified or waived as more fully specified in this Subsection:**

17 **(1) Notwithstanding the provisions of R.S. 17:5062, the deadline for**  
18 **taking the ACT or SAT for students graduating from high school in 2021 is**  
19 **December 31, 2021. The administering agency may provide an exception to this**  
20 **deadline if the student provides documentation that he was registered for a test**  
21 **that was canceled due to Hurricane Ida and was unable to schedule a test before**  
22 **the deadline due to circumstances beyond his control as determined by the**  
23 **administering agency. The administering agency shall not reduce the time**

1 period of eligibility for the award, as set forth in R.S. 17:5002, of an applicant  
2 who qualifies for an award pursuant to the authority granted by this  
3 Paragraph. The initial award or upgraded award shall be paid for the first time  
4 beginning with the semester during which the qualifying score was achieved.

5 (2) A student who is certified by his principal to have graduated during  
6 the 2021-2022 school year from an eligible out-of-state high school shall not be  
7 required to have a higher minimum composite score on the ACT than required  
8 by R.S. 17:5024 for a student who graduates from an eligible Louisiana high  
9 school.

10 (3) The requirement that a student complete a core curriculum shall be  
11 waived upon proper documentation by his principal that failure to comply is  
12 due solely to the fact that required courses were not available to the student at  
13 the school attended.

14 (4)(a) A dependent or independent student shall be deemed to meet  
15 program residency requirements if he actually resided in Louisiana during his  
16 entire eleventh grade year and was enrolled for such time in an eligible  
17 Louisiana high school or, for a dependent student, if he has a parent or  
18 court-ordered custodian who actually resided in an affected parish for at least  
19 the twelve months prior to August 27, 2021.

20 (b) A parent or court-ordered custodian of a dependent student who is  
21 eligible for a program award pursuant to the provisions of R.S. 17:5029, relative  
22 to students who graduate from certain out-of-state high schools and who was  
23 displaced as a resident from an affected parish shall be deemed to meet  
24 residency requirements if the parent or court-ordered custodian actually  
25 resided in Louisiana for at least the twelve months prior to August 27, 2021.

26 (5) A student who during the 2021-2022 school year successfully  
27 completes at the twelfth grade level a home study program approved by the  
28 State Board of Elementary and Secondary Education, referred to in this  
29 Subsection as the "state board", shall be eligible for a program award by  
30 complying with the provisions of R.S. 17:5029 relative to certain home study

1 students. In such case, the requirement that the student, if ever enrolled in an  
2 eligible Louisiana high school, begin the program no later than the end of the  
3 tenth grade is waived.

4 (6) The provisions of Paragraphs (2) through (5) of this Subsection shall  
5 apply only to a student who on August 27, 2021, was enrolled in a public or  
6 nonpublic high school that is located in an affected parish and that has the  
7 approval required by Part I of this Chapter for program eligibility purposes or  
8 who resided in such a parish and was enrolled in a home study program  
9 approved by the state board.

10 C.(1) Provisions of this Chapter relative to continuing eligibility are  
11 modified or waived with respect to the 2021-2022 academic year as more fully  
12 specified in this Subsection:

13 (a) The provisions of R.S. 17:5041 and 5042 requiring a student to make  
14 steady academic progress and achieve a certain cumulative grade point average  
15 are waived.

16 (b) For a student whose program award is suspended due to a low grade  
17 point average or failure to make steady academic progress, the time periods  
18 provided in Part I of this Chapter for him to meet such requirements before  
19 losing eligibility shall be extended by one semester for each semester that he is  
20 unable to enroll or complete.

21 (c) The provisions of R.S. 17:5043 providing that a student's eligibility  
22 shall be reduced by a semester for each semester that he is enrolled in an  
23 out-of-state college or university are waived.

24 (2) The provisions of this Subsection shall apply only to a person who, on  
25 August 27, 2021, was eligible for or had a program award and who meets either  
26 of the following criteria:

27 (a) His home of record was in an affected parish. For purposes of this  
28 Subparagraph, "home of record" means the domiciliary address of a dependent  
29 student's parent or court-ordered custodian or an independent student's  
30 domiciliary address.

1                   **(b) He was enrolled in an eligible college or university in an affected**  
 2                   **parish.**

3                   **(3) Notwithstanding the provisions of Paragraph (2), this Subsection**  
 4                   **shall also apply to a student who, on August 27, 2021, was a member of the**  
 5                   **Louisiana National Guard called to active duty to assist in the preparation for**  
 6                   **and response to Hurricane Ida.**

7                   **D. For purposes of this Section, "affected parish" means Jefferson,**  
 8                   **Lafourche, Livingston, Plaquemines, St. Charles, St. Helena, St. James, St. John**  
 9                   **the Baptist, Tangipahoa, or Terrebone.**

10                   **E.(1) The administering agency may waive any provision of Part I of this**  
 11                   **Chapter that imposes a program eligibility requirement that a student cannot**  
 12                   **comply with if it determines that the failure to comply is, more likely than not,**  
 13                   **due solely to the effects of Hurricane Ida.**

14                   **(2) The administering agency may waive any provision of Part I of this**  
 15                   **Chapter that imposes a program eligibility requirement that a student cannot**  
 16                   **comply with if it determines that the failure to comply is, more likely than not,**  
 17                   **due solely to the effects of any gubernatorially declared disaster or emergency.**  
 18                   **The authority granted by this Paragraph shall apply only to the 2021-2022**  
 19                   **academic year.**

20                   **(3) In addition to the provisions of the Administrative Procedure Act**  
 21                   **relative to legislative oversight, the Joint Legislative Committee on the Budget**  
 22                   **shall have oversight and approval authority over any rule proposed for**  
 23                   **adoption pursuant to the authority granted by this Subsection.**

24                   **F. The administering agency may adopt any rule, policy, or guideline**  
 25                   **necessary to implement the provisions of this Section and shall disseminate**  
 26                   **information regarding program changes pursuant to the provisions of this**  
 27                   **Section in the most timely manner possible.**

28                   Section 2. This Act shall become effective upon signature by the governor or, if not  
 29                   signed by the governor, upon expiration of the time for bills to become law without signature  
 30                   by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

1 vetoed by the governor and subsequently approved by the legislature, this Act shall become  
2 effective on the day following such approval.
