CONFERENCE COMMITTEE REPORT

HB 729 2022 Regular Session Duplessis

To the Honorable Speaker and Members of the House of Representatives and the Honorable President and Members of the Senate.

Ladies and Gentlemen:

We, the conferees appointed to confer over the disagreement between the two houses concerning House Bill No. 729 by Representative Duplessis, recommend the following concerning the Reengrossed bill:

- 1. That Senate Committee Amendments Nos. 1, 2, 3, 4, 7, and 9 by the Committee on Senate and Governmental Affairs (#3458) be adopted.
- 2. That Senate Committee Amendments Nos. 5, 6, and 8 by the Committee on Senate and Governmental Affairs (#3458) be rejected.
- 3. That the set of Senate Floor Amendments by Senator Hewitt (#4427) be rejected.
- 4. That the following amendments be adopted:

AMENDMENT NO. 1

On page 3, line 6, after "convicted" delete the remainder of the line and insert "of or pleads guilty or nolo contendere to a crime, lesser crime, or lesser included offense as defined in Article 558 in response to the same crime for which he was arrested or if there is criminal litigation related to the same crime that is pending or reasonably anticipated."

AMENDMENT NO. 2

On page 3, between lines 6 and 7, insert the following:

- "(e) The individual is charged with a crime of violence as defined in R.S. 14:2(B), except stalking, or charged with any of the following offenses:
 - (i) Sex offenses as defined in R.S. 15:541.
 - (ii) Human trafficking offenses as defined in R.S. 14:46.2 and 46.3.
 - (iii) Offenses affecting the health and morals of minors, R.S. 14:91 et seq.
- (iv) Offenses affecting the health and safety of person with infirmities, R.S.14:93.3 et seq.
 - (v) Video voyeurism.
 - (vi) Cruelty to animals.
 - (vii) Dogfighting."

AMENDMENT NO. 3

On page 3, line 7, change "Paragraph (2) of this Subsection" to "Subparagraph (1) of this Paragraph"

AMENDMENT NO. 4

On page 3, between lines 10 and 11, insert the following:

"(3) A booking photograph published, released, or disseminated by a law enforcement officer or agency, except after the subject of the booking photograph being found guilty or pleading guilty or nolo contendere as provided in

Subsubparagraph (B)(1)(d) of this Paragraph, shall include a disclaimer that states "all persons are presumed innocent until proven guilty".

(4) No law enforcement agency or employee thereof shall be subject to civil

(4) No law enforcement agency or employee thereof shall be subject to civil action or be held liable when the publication, release, or dissemination was made by mistake of fact or error, or was inadvertent and made in good faith."

Keyword and oneliner of the instrument as it left the House

CRIMINAL/RECORDS: Limits the release and dissemination of booking photographs of an arrested person

Report adopts Senate amendments to:

- 1. Change the definition of "booking photograph".
- 2. Provide additional grounds for the release of a booking photograph.
- 3. Require a disclaimer on booking photographs under certain circumstances.
- 4. Provide that law enforcement shall not be held liable if a booking photograph was released by mistake or inadvertent and made in good faith.
- 5. Make technical changes.

Report rejects Senate amendments which would have:

- 1. Allowed release of "filler" photographs pursuant to proposed law.
- 2. Required persons, other than law enforcement to include the disclaimer.

Report amends the bill to:

- 1. Limit the disclaimer on booking photographs to those released by law enforcement.
- 2. Make technical changes.

Digest of the bill as proposed by the Conference Committee

Present law (R.S. 44:1 et seq. – Public Records Law) provides that all books, records, writings, accounts, letters and letter books, maps, drawings, photographs, cards, tapes, recordings, memoranda, and papers, and all copies, duplicates, photographs, including microfilm, or other reproductions thereof, or any other documentary materials, regardless of physical form or characteristics, including information contained in electronic data processing equipment, having been used, being in use, or prepared, possessed, or retained for use in the conduct, transaction, or performance of any business, transaction, work, duty, or function which was conducted, transacted, or performed by or under the authority of the constitution or laws of the state, or by or under the authority of any ordinance, regulation, mandate, or order of any public body or concerning the receipt or payment of any money received or paid by or under the authority of the constitution or the laws of the state are "public records". Present law establishes a framework for the ready availability of public records to requesting persons and specifically provides that it is the duty of the custodian of the public records of a public entity or agency to provide copies to persons so requesting. Provides for certain exceptions, exemptions, and limitations.

<u>Proposed law</u> prohibits a law enforcement officer or agency from publishing, releasing, or disseminating a booking photograph, as defined by <u>proposed law</u>, to the public or to a private person or entity unless:

- (1) The individual is a fugitive and such release will assist in apprehending the individual.
- (2) The individual is an imminent threat and such release will assist in reducing or eliminating the threat.
- (3) A judge orders such release based upon a finding that the release is in furtherance of a legitimate interest.
- (4) The individual is convicted of the crime for which he was arrested or pleads guilty or nolo contendre to a crime, lesser crime, or lesser included offense in response to the same crime for which he was arrested.
- (5) Criminal litigation related to the crime is pending or reasonably anticipated.
- (6) The individual is charged with a crime of violence (except stalking) or charged with video voyeurism, cruelty to animals, dogfighting, sex offenses as defined in <u>present law</u> (R.S. 15:541), human trafficking offenses as defined in <u>present law</u> (R.S. 14:46.2 and 46.3), offenses affecting the health and morals of minors as provided in <u>present law</u> (R.S. 14:91 et seq.), or offenses affecting the health and safety of persons with infirmities as provided in present law (R.S.14:93.3 et seq.).

<u>Proposed law</u> requires a booking photograph published, released, or disseminated by a law enforcement officer or agency, except after the subject of the booking photograph has been found guilty or pled nolo contendre, shall include a disclaimer that states "all persons are presumed innocent until proven guilty".

<u>Proposed law</u> provides that no law enforcement agency or employee thereof shall be subject to civil action or be held liable when the publication, release, or dissemination was made by mistake or fact or error, or was inadvertent and made in good faith.

<u>Proposed law</u> defines "booking photograph" and "remove-for-pay publication or website" for its purposes.

<u>Proposed law</u> provides that a remove-for-pay publication or website shall remove and destroy a booking photograph of an individual who submits a request for removal and destruction within seven calendar days from the day that the individual makes the request if both of the following conditions exist:

- (1) The individual in the booking photograph was acquitted of the criminal charge or not prosecuted, or the individual had the criminal charge expunged, vacated, or pardoned.
- (2) The individual submits, in relation to the request, evidence of a disposition described in proposed law.

<u>Proposed law</u> provides that if the remove-for-pay publication or website does not remove and destroy the booking photograph, the remove-for-pay publication or website shall be liable for all costs, including reasonable attorney fees, resulting from any legal action that the individual brings in relation to the failure of the remove-for-pay publication or website to remove and destroy the booking photograph.

<u>Proposed law</u> provides that any remove-for-pay publication or website that seeks any fee or other valuable consideration for the removal or destruction of a booking photograph shall be subject to prosecution under <u>present law</u> (R.S. 14:66 – the crime of extortion).

<u>Proposed law</u> further specifies that the publication of a booking photograph of a La. resident constitutes minimum contact with the state and by doing so, the party shall be subject to the jurisdiction of La. courts.

Effective upon signature of governor or lapse of time for gubernatorial action.
