2	To amend and reenact R.S. 30:1107(C), relative to carbon sequestration operations; to
3	provide for duties, obligations, and responsibilities for the transport and storage of
4	carbon dioxide; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 30:1107(C) is hereby amended and reenacted to read as follows:
7	§1107. Certificates of public convenience and necessity; certificate of completion of
8	injection operations

10	C. Anything in this Chapter, or in any rule, regulation, or order issued by the
11	commissioner under this Chapter to the contrary notwithstanding, accepting or acting
12	pursuant to a certificate of public convenience and necessity or a certificate of
13	completion of injection operations issued under this Chapter, compliance with the
14	provisions of this Chapter, or with rules, regulations, or orders issued by the
15	commissioner under this Chapter, or voluntarily performing any act or acts which
16	could be required by the commissioner pursuant to this Chapter, or rules, regulations,
17	or orders issued by the commissioner under this Chapter, shall not have the following

<u>Present law</u> provides for certificates of public convenience and necessity for injection operations and establishes conditions for the issuance thereof.

<u>Present law</u> precludes imposition of certain consequences against storage operators and carbon dioxide transporters, including classification as a common carrier or public utility, subjection to duties, obligations, or liabilities as a common carrier or public utility, or increase of tax liability, where the storage operator or carbon dioxide transporter acts in compliance with a certificate of public convenience and necessity or certificate of completion of injection or acts in compliance with statutes, rules, regulations, or orders issued by the commissioner of the Dept. of Natural Resources, office of conservation.

Proposed law retains present law.

Effective August 1, 2023.
