| 15 | §192. Annual canvass; costs |
| 16 | A.(1)(a) No later than June thirtieth in each parish, the registrar of voters |
| 17 | shall annually canvass the names of the registrants in all precincts in the parish. |

Failure of the registrar to conduct an annual canvass as provided in this Paragraph shall constitute willful misconduct relating to his official duty for the purposes of R.S. 18:53. The Department of State shall use the United States Postal Service or its licensee to verify the names, and addresses, and homestead exemptions of the registrants in all precincts in the state. A verification by the United States Postal Service or its licensee shall constitute a valid canvass of the registered voter.

Present law establishes criteria for a registrant to change his voter registration.

<u>Proposed law</u> allows for the correction of errors made by a registrar of voters to a voter registration at any time.

<u>Present law</u> requires the Dept. of State to use the United States Postal Service or its licensee to verify the names and addresses of the registrants in all precincts in the state and establishes that such a verification constitutes a valid canvass of the registered voter.

<u>Proposed law</u> retains <u>present law</u> and further requires verification of the registrants' homestead exemption.

Effective August 1, 2023.
