However, the portion of taxes that is not in dispute shall be paid 23 without being made subject to the protest. 24 B.(1) 25 (3) Any taxpayer in the state who has filed suit under these provisions and 26 whose taxes have become due shall pay said taxes under protest or timely file a rule 27 to set bond or other security pursuant to R.S. 47:2134 and shall cause to issue a 28 notice to the officer designated by law for the collection of such tax under the 29 provisions of R.S. 47:2134(B), and shall cause service of process to be made on the 30 Louisiana Tax Commission as provided for in R.S. 47:2134(B). However, the portion 31 of taxes that is not in dispute shall be paid without being made subject to the protest.
