COMMENDATIONS. Commends Isiah Chavis for winning the 2023 George A. Spiegelberg Award as Best Oral Advocate at the National Trial Competition.

1	A RESOLUTION
2	To commend and congratulate Isiah Chavis for winning the 2023 George A. Spiegelberg
3	Award as Best Oral Advocate at the National Trial Competition.
4	WHEREAS, the National Trial Competition was established in 1975 to encourage
5	and strengthen student's advocacy skills through quality competition and valuable interaction
6	with members of the bench and bar; and
7	WHEREAS, the competition is designed to expose law students to the nature of trial
8	practice and serve as a supplement to their education; and
9	WHEREAS, the competition, which attracts teams from more than 150 law schools
10	and involves more than 1,000 law students, allows for a team of two law students from the
11	same school to represent fictitious parties that are either the plaintiff/prosecutor or the
12	defendant in a mock trial; and
13	WHEREAS, the students are scored by members of the bench and bar on how they
14	present and argue their side of the case through their opening statements, closing arguments,
15	direct and cross examination of witnesses, and pretrial, and during trial motions and
16	objections; and
17	WHEREAS, to compete at the national event, participants must be one of the top two
18	teams at one of the fifteen regional qualifiers, and at both the regional and national stage of

1	the competition, teams qualify through competition in preliminary rounds, a quarterfinal
2	round, a semi-final round, and then the final round; and
3	WHEREAS, at the 2023 National Trial Competition held in San Antonio, Texas, on
4	March 30th through April 3rd, the Mercer University team of Isiah Chavis and John Flowers
5	made it to the semi-final round and Isiah Chavis was awarded the George A. Spiegelberg
6	Award for the Best Oral Advocate of the competition; and
7	WHEREAS, originally from Church Point, Louisiana, Isiah is currently a third-year
8	law student at Mercer University School of Law in Macon, Georgia, a 2020 graduate of
9	University of Louisiana at Monroe in Monroe, Louisiana, and a 2016 graduate of Northside
10	High School in Lafayette, Louisiana; and
11	WHEREAS, Isiah has been competing and excelling in mock trail competitions since
12	high school and has been coached along his way by Liz Tullier in high school, Bob Noel and
13	Kyle Moore in college, and Katie Powers in law school; and
14	WHEREAS, Isiah attributes his success and that of his team to many hours of
15	dedicated practice and preparation; to his coaches, he is known for his strong work ethic and
16	true leadership; and
17	WHEREAS, the hard work and success achieved by Isiah Chavis in being named the
18	best advocate in the country in the National Trial Competition merits a special measure of
19	commendation for the pride it brings to his hometown of Church Point and his home state
20	of Louisiana.
21	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
22	does hereby commend and congratulate Isiah Chavis for winning the 2023 George A.
23	Spiegelberg Award as Best Oral Advocate at the National Trial Competition.
