CRIMINAL/PROCEDURE: Provides relative to the DNA database exchange

To amend and reenact R.S. 15:612(A)(introductory paragraph), (B), and (C), relative to

DNA database exchange; to provide relative to the population database comprised

of DNA samples; to provide relative to the use of the population database comprised

of DNA samples; to provide relative to disclosure prohibitions of the database; and

to provide for related matters.

AN ACT

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 15:612(A)(introductory paragraph), (B), and (C) are hereby amended and reenacted to read as follows:

§612. DNA data base database exchange

A. The state police shall receive, store, and perform analysis on DNA samples or contract for DNA typing analysis with a qualified DNA laboratory that meets the guidelines as established by the state police, and shall classify and file the DNA record of identification characteristic profiles of DNA samples submitted under this Chapter and make such information available as provided in this Section. The state police may enter a contract for the storage of DNA typing analysis and for DNA typing analysis with a qualified DNA laboratory that meets guidelines as established by the state police. The results of the DNA profile of individuals in the state DNA data base database shall be made available:

Abstract: Provides relative to the use of the population database comprised of DNA samples.

<u>Present law</u> authorizes state police to create a separate population database comprised of DNA samples after all personal identification is removed. Further authorizes state police to share or disseminate the population database with other criminal justice agencies or crime laboratories that serve to assist state police with statistical databases.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> retains <u>present law</u> and provides that the population database may be used for the following:

- (1) To assist federal, state, and local criminal justice and law enforcement agencies in the identification and detection of individuals in criminal investigations or in declared or non-declared disaster victim identification.
- (2) For a population statistics database.
- (3) For identification and protocol development purposes.
- (4) For quality control purposes.

<u>Proposed law</u> requires state police to maintain the separate population database and requires that the database is subject to the same disclosure prohibitions as the state data bank pursuant to present law (R.S. 15:617).
