Increases penalties for violations of shrimp and crawfish labeling requirements in food service establishments

Proposed law provides for civil penalties for mislabeling imported crawfish and shrimp under the sanitation code; removes the district attorney's jurisdiction over violations; authorizes the Louisiana Department of Wildlife and Fisheries (LDWF) to enforce and collect civil penalties.

## **EXPENDITURE EXPLANATION**

Proposed law will increase expenditures for the Louisiana Department of Wildlife and Fisheries (LDWF) to enforce and adjudicate civil penalties associated with labeling imported shrimp and crawfish. The department estimates an increase of \$100,000 in overtime hours for the Enforcement Division, which would be funded through the Shrimp Marketing and Promotion Account. The LFO cannot corroborate the overtime needs detailed by LDWF. To the extent overtime hours are less than expected, costs would decrease proportionally. The cost of an adjudicatory hearing is unknown at this time. Any increase in expenditures for adjudication would be paid out of the Conservation Fund.

Removing jurisdiction from the District Attorneys may decrease their overall workload and any costs associated with prosecuting these penalties.

## **REVENUE EXPLANATION**

Proposed law may lead to an increase in revenues collected by the Louisiana Department of Wildlife and Fisheries (LDWF) and a decrease in revenues collected by district attorneys. The level of compliance with shrimp and crawfish labeling is unknown at this time. All fine amounts collected by LDWF will be deposited into the Conservation Fund.

In addition, to the extent the Louisiana Department of Health (LDH) has the ability to collect civil penalties following an adjudication hearing under sanitation code provisions, revenues collected by LDH may also increase.
