FEES/LICENSES/PERMITS: Increases certain fees for justice of the peace courts

2	To amend and reenact R.S. 13:2590(A)(1), (2), (3), (23), and (30), relative to justice of the
3	peace court costs; to provide for an increase in court costs collected by a justice of
4	the peace for the filing and service of certain pleadings and judgments in civil
5	matters; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 13:2590(A)(1), (2), (3), (23), and (30) are hereby amended and
8	reenacted to read as follows:
9	§2590. Security for costs
10	A. A justice of the peace may demand and receive up to the following
11	amounts in all civil matters:
12	(1) New suit: one hundred thirty dollars, and twenty dollars per additional
13	defendant.
14	(2) Eviction proceeding: one hundred twenty dollars, and twenty dollars per
15	additional defendant.
16	(3) Writ of execution: forty sixty dollars, and twenty dollars per additional

Abstract: Increases certain fees for justice of the peace courts in civil matters.

<u>Present law</u> provides a fee schedule for justice of the peace courts.

<u>Proposed law</u> retains <u>present law</u> and increases certain fees in civil matters including the following:

(1) New suit: <u>from</u> \$100 <u>to</u> \$130

(2) Eviction proceeding: from \$100 to \$120

(3) Writ of execution: from \$40 to \$60

(4) Service of judgment: from \$20 to \$30

(5) Additional service of process: from \$20 to \$30

Proposed law adds an out of district service of process fee with an amount of \$30.

(Amends R.S. 13:2590(A)(1), (2), (3), (23), and (30))

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:

- 1. Change the proposed fee increase for new suits from \$140 to \$130.
- 2. Change the proposed fee increase in eviction proceedings from \$140 to \$120.
- 3. Change the proposed fee increase for a writ of execution from \$80 to \$60.
