

**SENATE COMMITTEE AMENDMENTS**

2023 Regular Session

Amendments proposed by Senate Committee on Finance to Engrossed Senate Bill No. 41  
by Senator Mizell

1 AMENDMENT NO. 1

2 On page 1, line 7, after "credits;" delete the remainder of the line , delete line 8 in its  
3 entirety, and insert "to authorize the Louisiana Department of Health to promulgate rules;  
4 to require the Department of Revenue to promulgate rules; to"

5 AMENDMENT NO. 2

6 On page 3, line 12, after "equal to" change "five" to "fifty"

7 AMENDMENT NO. 3

8 On page 3, line 20, after "more than" change "five" to "twenty"

9 AMENDMENT NO. 4

10 On page 4, line 3, change "Registry" to "Registration"

11 AMENDMENT NO. 5

12 On page 4, delete lines 4 through 29 and insert the following:

13 **"A.(1) The Louisiana Department of Health shall create an electronic or**  
14 **downloadable registration form for eligible maternal wellness centers. An**  
15 **eligible maternal wellness center may voluntarily register with the Louisiana**  
16 **Department of Health by completing and submitting the registration form to**  
17 **the Louisiana Department of Health.**

18 **(2) The registration form shall be located on the department's website**  
19 **under the Office of Women's Health and Community Health page.**

20 **B.(1) The Louisiana Department of Health shall formulate a list of**  
21 **registered eligible maternal wellness centers based solely on the registration**  
22 **forms submitted to the Louisiana Department of Health. The purpose of the list**  
23 **shall be to function as a single database of eligible maternal wellness centers**  
24 **located in Louisiana.**

25 **(2) The Louisiana Department of Health shall publish and make the list**  
26 **available to the public on its website.**

27 **(3) The list shall not include any organization involved in, or associated**  
28 **with counseling for, or referrals to, abortion clinics, providing medical**  
29 **abortion-related procedures, or pro-abortion advertising.**

30 **C. The Louisiana Department of Health shall have no regulatory**  
31 **authority over registered eligible maternal wellness centers and shall not be**  
32 **required to verify the eligibility of an eligible maternal wellness center pursuant**  
33 **to this Chapter.**

34 **D. The Louisiana Department of Health shall post a link on its website**  
35 **that contains an overview of available resources, including but not limited to,**  
36 **information on Louisiana Medicaid services, the Special Supplemental**  
37 **Nutrition Program for Women, Infants and Children, parish health unit**  
38 **services, and locations of parish health units."**

2 On page 5, line 3, after "**Registered**" and before "**maternal**" insert "**eligible**"

3 AMENDMENT NO. 8

4 On page 5, line 4, after "**Health**" and before "**no later**" insert "**and the Department of**  
5 **Revenue**"

6 AMENDMENT NO. 9

7 On page 5, delete lines 25 through 29 and insert the following:

8 **"B.(1) The Louisiana Department of Health may promulgate rules and**  
9 **regulations necessary for the implementation of this Chapter in accordance with**  
10 **the provisions of the Administrative Procedure Act."**
