AN ACT

INSURANCE/HEALTH: Provides relative to maternity support services of doulas

2	To amend and reenact R.S. 22:1059.2 and to enact R.S. 22:1059.3, relative to maternity
3	support services provided by doulas; to require health insurance coverage for such
4	maternity support services; to provide for legislative findings; to provide for
5	definitions; to provide for the redesignation of certain statutes; to provide for
6	effectiveness; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 22:1059.2 is hereby amended and reenacted and R.S. 22:1059.3 is
9	hereby enacted to read as follows:
10	§1059.2. Required coverage for maternity support services provided by doulas;
11	legislative findings; definitions
12	A. The legislature hereby finds and affirms all of the following:
13	(1) A doula is an individual who has been trained to provide physical,
14	emotional, and educational support, but not medical or midwifery care, to pregnant
15	and birthing women and their families before, during, and after childbirth.
16	(2) Leading professional societies such as the American College of
17	Obstetricians and Gynecologists and the Society for Maternal-Fetal Medicine, and
18	federal agencies such as the Centers for Disease Control and Prevention, the Health
19	Resources and Services Administration, and the Centers for Medicare and Medicaid
20	Services have recognized the well-established benefits of maternity support services
21	provided by doulas.

1	(3) Research has demonstrated that support from a doula is associated with
2	lower cesarean section rates, fewer obstetric interventions, fewer complications
3	during and after childbirth, decreased use of pain medication, shorter labor hours,
4	and higher scores on the Apgar test, which indicates how well a baby is doing
5	outside the womb.
6	(4) As Louisiana currently ranks as a state with one of the highest maternal
7	and infant mortality rates in the United States, this state has a compelling interest in
8	and obligation to promote practices that improve maternal and infant health
9	outcomes.
10	B.(1) A health coverage plan delivered or issued for delivery in this state that
11	provides benefits for maternity services shall include coverage for maternity support
12	services provided by a doula to pregnant and birthing women and their families
13	before, during, and after childbirth.
14	(2) The coverage required pursuant to this Section may be subject to annual
15	deductibles, coinsurance, and copayment provisions as are consistent with those
16	established under the health coverage plan. The coverage may also be subject to an
17	annual limit not to exceed one thousand five hundred dollars.
18	(3)(a) The requirements established by a health coverage plan to insure the
19	maternity support services provided by a doula before, during, and after childbirth
20	shall not preclude a doula from practice in this state.
21	(b) A doula may opt to practice in this state and forego any eligible
22	reimbursement via a health coverage plan; however, a doula opting for
23	reimbursement via a health coverage plan shall apply to the Louisiana Doula
24	Registry Board for registration and receive an approved registration status.
25	(c) In addition to the registration prescribed in Subparagraph (b) of this
26	Paragraph, a health insurance issuer or health coverage plan may establish additional
27	credentialing standards for contracting with doulas.

2	discriminatory against doulas or maternity support services provided by doulas is
3	void and unenforceable.

12	§1059.3. Required coverage for prescribed donor human milk
13	A health coverage plan issued for delivery, delivered, renewed, or otherwise
4	contracted for in this state shall provide inpatient and outpatient coverage benefits
15	for up to two months for medically necessary pasteurized donor human milk upon
16	prescription of an infant's pediatrician or licensed pediatric provider stating that the
17	infant is medically or physically unable to receive maternal human milk or
8	participate in breastfeeding, or the infant's mother is medically or physically unable
9	to produce maternal human milk in sufficient quantities. A health coverage plan may
20	limit coverage under this Section to inpatient and outpatient donor human milk
21	obtained from a member bank of the Human Milk Banking Association of North
22	America.
23	Section 2. The provisions of this Act apply to any new policy, contract, program, or
24	health coverage plan issued on and after January 1, 2024. Any policy, contract, or health
25	coverage plan in effect prior to January 1, 2024, shall convert to conform to the provisions

of this Act on or before the renewal date, but no later than January 1, 2025.

**Abstract:** Requires health insurance coverage for maternity support services provided by a doula.

<u>Proposed law</u> affirms a doula as an individual who is trained to provide physical, emotional, and educational support, but not medical or midwifery care, to pregnant and birthing women and their families before, during, and after childbirth.

<u>Proposed law</u> outlines legislative findings with respect to doulas. Affirms the state of La. as a state with one of the highest maternal and infant mortality rates in the U.S. Further affirms that the state of La. has a compelling interest and obligation to promote practices that improve maternal and infant health outcomes.

<u>Proposed law</u> requires a health coverage plan delivered or issued for delivery in this state that provides benefits for maternity services to include coverage for maternity support services provided by a doula to pregnant and birthing women and their families before, during, and after childbirth.

<u>Proposed law</u> provides that the coverage may be subject to annual deductibles, coinsurance, and copayment provisions as are consistent with those established under the health coverage plan. Further provides that such coverage may also be subject to an annual limit of \$1,500.

<u>Proposed law</u> prohibits a health coverage plan from prescribing coverage requirements for maternity support services of a doula that preclude a doula from practice in this state. Authorizes a doula to practice in this state while foregoing eligible reimbursement via a health coverage plan; however, <u>proposed law</u> requires a doula opting for reimbursement via a health coverage plan to have approved registration with the La. Doula Registry Board.

<u>Proposed law</u> authorizes a health insurance issuer or health coverage plan to establish additional credentialing standards for contracting with doulas.

<u>Proposed law</u> prohibits terminology in any health coverage plan or contract deemed discriminatory against doulas and maternity support services provided by doulas. Further provides that such terminology is void and unenforceable.

Proposed law defines "doula", "health coverage plan", and "maternity support services".

<u>Proposed law</u> applies to a policy, contract, or health coverage plan issued on and after Jan. 1, 2024 and requires a current policy, contract, or plan to convert to the provisions of proposed law by Jan. 1, 2025.

<u>Present law</u> (R.S. 22:1059.2) requires a health coverage plan to provide inpatient and outpatient coverage benefits for up to 2 months for medically necessary pasteurized donor human milk under certain conditions. <u>Proposed law</u> redesignates the citation of <u>present law</u> from R.S. 22:1059.2 to R.S. 22:1059.3 and otherwise retains <u>present law</u>.

(Amends R.S. 22:1059.2; Adds R.S. 22:1059.3)

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Insurance</u> to the <u>original</u> bill:

- 1. Create consistency with current proposed law.
- 2. Add that coverage may also be subject to an annual limit of \$1,500.
- 3. Add that a health insurance issuer or health coverage plan may establish additional credentialing standards for contracting with doulas.
- 4. Change the year <u>from 2024 to 2025</u> for which a current policy, contract, or plan is required to convert to the requirements of <u>proposed law</u>.
