Proposed law establishes the Universities of Louisiana Maritime Academy within the University of Louisiana System (ULS) under the direction of the system's board of supervisors and subject to powers, duties, and responsibilities of the Board of Regents. The academy's purpose is to 1. leverage and coordinate existing maritime programs; 2. train merchant marine officers; 3. provide pathways that align with the workforce needs of the maritime industry. Allows for the hiring of an Executive Director who can create an advisory board to assist in the establishment and operations of the academy. Training programs within the academy may operate across institutions within the ULS.

## **EXPENDITURE EXPLANATION**

There will be an increase in expenditures to initiate the Maritime Academy. The University of Louisiana System reports the hiring of an executive director for the Maritime Academy at an estimated compensation of \$210,000 (\$150,000 Salary, \$60,000 Related Benefits) which factors a 3% annual increase in the ensuing years. Existing academic programs within the UL System institutions will be adapted into the Academy.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
