16 (1) "Community health worker" means an individual who serves as a liaison 17 for community members to facilitate access to health and social services and to 18 improve quality and cultural competence of service delivery through outreach, 19 education, support and advocacy. "Community health worker" does not include an 20 individual who provides clinical services.

21 (2) "Department" means the Louisiana Department of Health."

9	A. The board shall meet twice a year. Members of the board shall serve
10	without compensation.
11	B. The Louisiana State University Health Science Center, Center for
12	Healthcare Value and Equity, shall provide staffing for the board.
13	C. The board shall develop all of the following:
14	(1) A recommended program to enhance employer readiness in hiring
15	community health workers.
16	(2) Recommendations for core skills, roles, and competencies for community
17	health workers in Louisiana.
18	(3) Recommended standards and requirements for community health worker
19	education and training programs, including recommended standards for community
20	health worker educators.
21	(4) Recommendations for sustainable methods of financing for community
22	health worker services.
23	D. The board may do all of the following:
24	(1) Review community health worker training programs.
25	(2) Make recommendations to community health worker training programs.
26	(3) Track employment of community health workers in Louisiana from
27	information provided voluntarily to the board by entities such as employers or
28	community-based organizations.
29	§3725. Department powers and duties
30	The department, in consultation with the board, may adopt rules pursuant to
31	the Administrative Procedure Act to implement core skills, roles, and competencies
32	for community health workers; to implement standards and requirements for
33	community health worker education and training programs; and to implement
34	standards for community health worker education.
35	§3726. Termination
36	The Board shall terminate operations on December 31, 2028.
37	Section 2. Notwithstanding any provision of law to the contrary, the Louisiana
38	Community Health Worker Workforce Board shall elect a chair at its first meeting."
