## **EXPENDITURE EXPLANATION**

Proposed law will create a one-time expenditure impact of \$95,000 in the Department of Public Safety (DPS), Office of Motor Vehicles (OMV). The proposed law requires National Suicide Prevention Lifeline "Suicide Lifeline dial 988" be printed on every driver's license and personal identification card and on the home page of LA Wallet website. To implement this measure, DPS estimates a one-time cost of \$80,000 for OMV's card vendor to print "Suicide Lifeline dial 988" on the back of all consumable cards. In addition, DPS estimates a one-time cost of \$15,000 for the digital license vendor, LA Wallet, to place the words "Suicide Lifeline dial 988" on the home page of the application. Total one-time expenditures of \$95,000 (\$80,000 consumable cards and \$15,000 website).

The Legislative Fiscal Office believes that any additional IT work associated with this legislation will be incremental in nature and the department can potentially accomplish these tasks utilizing existing resources and budget authority as similar changes are enacted annually by legislative instruments and paid from base funding. To the extent that numerous pieces of legislation are enacted that require additional programming efforts, the department may require additional resources.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
