- 4 On page 6, between line 4 and line 5, insert the following:
 - "(10)(a) If, after examining the evidence, the attorney general concludes that a violation of this Section occurred, the attorney general shall order the foreign adversary to divest himself of all interests in the land within ninety days after service of the order upon the foreign adversary.
 - (b) The order of divestiture, as described in Subparagraph (a) of this Paragraph, shall be served personally or by mail.
- 12 (11)(a) If the holder of the interest that is ordered to be divested disputes the 13 determination of the attorney general that a violation of this Section occurred, the 14 holder may submit a written request for a judicial determination to the attorney 15 general.
- 16 (b) The written request, as described in Subparagraph (a) of this Paragraph, 17 shall be delivered to the attorney general within sixty days after service of the order 18 of divestiture. If no written request is received within this time, the determination of the attorney general shall become final. 19
- 20 (12)(a) If the foreign adversary fails to divest himself of all interests pursuant 21 to Subparagraph (10)(a) of this Subsection or if a holder of the interest submits a 22 written request pursuant to Paragraph (11) of this Subsection, the attorney general shall bring an action to divest the interest. 23
- (b) The attorney general may initiate a civil action pursuant to this Section 25 in either the parish of East Baton Rouge or a parish where a portion of the immovable property is located.
- 27 (c) The attorney general shall record in the public mortgage records of the parish clerk of court of each parish in which any portion of the immovable property 28 29 is located a notice of pendency of the action pursuant to Book 7, Title 2, Chapter 4 30 of the Code of Civil Procedure.
- 31 (13) If the holder of the interest in immovable property has submitted a 32 written request pursuant to Paragraph (11) of this Subsection, the court shall conduct 33 an evidentiary hearing to determine, by a preponderance of the evidence, if a 34 violation of this Section occurred, prior to taking any other action. If the court 35 determines that there has been no violation, the court shall dismiss the action and 36 expunge the notice of pending action.
- (14) If a court of competent jurisdiction determines that a violation of this 37 Section occurred, the court shall order that such immovable property be sold by the 38 39 sheriff in the parish where the immovable property is located in the same manner as 40 a judicial sale in accordance with the requirements of Book 4, Title 2, Chapter 2 of 41 the Code of Civil Procedure."
