25 Chapter 28 of Title 12 of the Louisiana Revised Statutes of 1950, to be comprised
26 of R.S. 12:1851 through 1870.

27 (B) The Louisiana State Law Institute is hereby directed to change any
28 references in the Codes or Louisiana Revised Statutes of 1950 as necessary to reflect
29 the citation changes effected by this Section." "
