 40:1300.51 through 1300.53, and to repeal Act No. 231 of the 2019 Regular Session

- 6 <u>AMENDMENT NO. 2</u>

On page 1, line 3, after "Law;" delete the remainder of the line, delete line 4 in its entirety
and at the beginning of line 5, delete "Law;" and insert the following:

9 "to provide relative to mitragynine speciosa; to prohibit the sale or distribution of 10 mitragynine speciosa to persons under the age of twenty-one; to provide relative to 11 local ordinances with respect to mitragynine speciosa;"

- 13 On page 1, between lines 6 and 7, insert the following:
- 14 "Section 1. R.S. 14:91.10 is hereby enacted to read as follows:

15 §91.10. Unlawful sale or distribution of mitragynine speciosa to persons under 16 age twenty-one; penalty 17 A. No person shall sell or distribute or cause to be sold or distributed a 18 product containing mitragynine speciosa to any person under the age of twenty-19 one. B. For purposes of this Section, "mitragynine speciosa" means a product 20 21 containing either or both of the following: 22 (a) Mitragynine. 23 (b) 7-Hydroxy-mitragynine. 24 C. Whoever violates the provisions of this Section shall be fined not 25 more than five hundred dollars, imprisoned for not more than six months, or 26 both. 27 Section 2. Part VI of Chapter 5-G of Title 40, comprised of R.S. 40:1300.51 through 1300.53, is hereby enacted to read as follows: 28 29 PART VI. LOCAL OPTION FOR 30 **CONTROL OF MITRAGYNINE SPECIOSA** 31 <u>§1300.51. Short title</u> 32 This Part shall be known and may be cited as the "Local Option for 33 Mitragynine Speciosa". 34 §1300.52. Definitions 35 As used in this Part, the following terms have the following meanings 36 ascribed to them unless the context clearly indicates otherwise: 37 (1) "Local government" means a parish or municipality, as provided 38 pursuant to Article VI, Part I, Sections 1 and 2 of the Constitution of Louisiana.

1(2) "Mitragynine speciosa" shall have the same meaning as defined in2R.S. 14:91.10.

3 §1300.53. Local government prohibition or regulation

4 Notwithstanding any other provision of law to the contrary, a local 5 government may enact an ordinance to prohibit the sale or distribution of 6 mitragynine speciosa products or to regulate the sale or distribution of 7 mitragynine speciosa products in a manner that is more restrictive than 8 provided for in R.S. 14:91.10."

 repealed in its entirety."
