A RESOLUTION

2 To recognize Tuesday, June 6, 2023, as Habitat for Humanity Day in Louisiana. 3 WHEREAS, Habitat for Humanity's mission is to put God's love into action by 4 bringing people together to build homes, communities, and hope, and its vision is a world 5 where everyone has a decent place to live; and 6 WHEREAS, Habitat for Humanity's core principles are to demonstrate the love of 7 Jesus Christ, focus on shelter, advocate for affordable housing, promote dignity and hope, 8 and support sustainable and transformative development; furthermore, the organization and 9 its affiliates do not proselytize the individuals they assist; and 10 WHEREAS, Habitat for Humanity partners with people in the community and across 11 the world to help build or improve homes; the homeowners work alongside volunteers 12 throughout the construction period and pay affordable mortgages, and the support of the 13 community empowers these individuals to achieve the strength, stability, and independence 14 they need to build a better life for themselves and their families; and 15 WHEREAS, the New Orleans Area Habitat for Humanity (NOAHH) is a 501(c)(3) 16 nonprofit organization that was incorporated in 1983 as an independent affiliate of Habitat 17 for Humanity International; since its inception, NOAHH has built over seven hundred fifty 18 homes and repaired over three hundred more in the New Orleans area; between 2006 and 19 2012, the organization had a \$307 million impact on the New Orleans economy; and 20 WHEREAS, the New Orleans Habitat's Musicians' Village is one of the most 21 significant achievements of NOAHH; the village consists of seventy-two single-family

1 homes, five elder friendly duplexes, a toddler-friendly pocket park, and the Ellis Marsalis

2 Community Centers, and 80% of the homes in the Musicians' Village core site house
