1	AN ACT
2	To enact R.S. 36:4(B)(1)(l) and Subpart C-2 of Part I of Chapter 1 of Subtitle I of Title 39
3	of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 39:15.11 through
4	15.15, relative to the Louisiana Cybersecurity Commission; to create the Louisiana
5	Cybersecurity Commission within the division of administration; to provide for
6	legislative intent; to provide for definitions; to provide for commission membership;
7	to provide for the powers and duties of the commission; to provide for staffing; to
8	provide for an annual report; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 36:4(B)(1)(l) is hereby enacted to read as follows:
11	§4. Structure of executive branch of state government
12	* * *
13	B. The office of the governor shall be in the executive branch of state
14	government. The governor may allocate within his office the powers, duties, funds,
15	functions, appropriations, responsibilities, and personnel of the agencies within his

1	office and provide for the administration thereof and for the organization of his
2	office. The following agencies and their powers, duties, functions, and
3	responsibilities are hereby transferred to the office of the governor:
4	(1) Division of administration (including but not limited to Subtitle I of Title
5	39 of the Louisiana Revised Statutes of 1950 generally). The following agencies are
6	placed within the division of administration:

8	(1) Louisiana Cybersecurity Commission (R.S. 39:15.11 et seq.).

10	Section 2. Subpart of C-2 of Part I of Chapter 1 of Subtitle I of Title 39 of the
11	Louisiana Revised Statutes of 1950, comprised of R.S. 39:15.11 through 15.15, is
12	hereby enacted to read as follows:
13	SUBPART C-2. LOUISIANA CYBERSECURITY COMMISSION
14	<u>§15.11. Legislative intent</u>
15	The legislature of Louisiana hereby finds all of the following:
16	(1) The mission of the Louisiana Cybersecurity Commission, which was
17	created by executive order of the governor, is the coordination of cybersecurity
18	efforts among local, state, tribal, and federal governments, as well as the private
19	sector to maintain the stability of public services while ensuring proper privacy
20	and protection of data entrusted to the state.
21	(2) Information systems, networks, and critical infrastructure around the
22	world are threatened by increasingly sophisticated cyber-attacks.
23	(3) Cyber-attacks aimed at breaching and damaging computers,
24	networks, and critical infrastructure in Louisiana represent a major security
25	risk and increase the state's vulnerability to economic disruption, critical
26	infrastructure damage, privacy violations, and identity theft.
27	(4) The increasing number and complexity of cyber-attacks demand
28	heightened levels of coordination, information sharing, and emergency response
29	between local, state, tribal, and federal governments and the private sector to
30	protect computer networks and critical infrastructure, as defined by the

1	Cybersecurity and Infrastructure Agency of the federal Department of
2	Homeland Security, from damage or unauthorized access.
3	(5) As a result of the increasing threat of cyber-attacks and to solidify the
4	collaboration between governments and the private sector, the Louisiana
5	Cybersecurity Commission shall be formally created to ensure continuation of
6	its important mission. The commission's proven track record of improving the
7	resiliency of the cyber ecosystems in the state of Louisiana justify and warrant
8	its statutory creation.
9	<u>§15.12. Definitions</u>
10	As used in this Part, these terms shall have the following meanings:
11	(1) "Commission" means the Louisiana Cybersecurity Commission.
12	(2) "Critical infrastructure sectors" includes the following sectors which
13	the Cybersecurity and Infrastructure Security Agency of the federal
14	Department of Homeland Security has identified as critical:
15	(a) Chemical.
16	(b) Commercial facilities.
17	(c) Communications.
18	(d) Critical manufacturing.
19	<u>(e) Dams.</u>
20	(f) Defense industrial base.
21	(g) Emergency services.
22	(h) Energy.
23	(i) Financial services.
24	(j) Food and agriculture.
25	<u>(k) Government facilities.</u>
26	(1) Healthcare and public health.
27	(m) Information technology.
28	(n) Nuclear reactors, materials, and waste.
29	(o) Transportation systems.
30	(p) Water and wastewater systems.

1	(q) Any other sector which the Cybersecurity and Infrastructure
2	Security Agency deems to be critical in the future.
3	<u>§15.13. Louisiana Cybersecurity Commission; creation; membership</u>
4	A. The Louisiana Cybersecurity Commission is hereby created within
5	the division of administration to coordinate cybersecurity efforts among state
6	governmental entities, local governments, tribal governments, private
7	companies, academic institutions, and other entities in both the public and
8	private sectors. The commission shall encourage participation by federal
9	agencies and private sector stakeholders to ensure that the objectives of the
10	commission are met and to ensure proper coordination between the state, local,
11	and federal government agencies and private companies.
12	B.(1) The commission shall be composed of the following twenty-one
13	members, eleven of which are appointed by virtue of their governmental
14	positions and ten members appointed by the governor:
15	(a) The state chief information officer.
16	<u>(b) The adjutant general.</u>
17	(c) The commissioner of higher education.
18	(d) The superintendent of the Louisiana State Police.
19	(e) The attorney general.
20	(f) The secretary of state.
21	(g) The secretary of economic development.
22	(h) The chairman of the Public Service Commission.
23	(i) The director of the Governor's Office of Homeland Security and
24	Emergency Preparedness.
25	(j) The chairman of the House Select Committee on Homeland Security.
26	(k) The chairman of the Senate Select Committee on Homeland Security.
27	(1) Four members appointed by the governor from institutions of higher
28	education in this state. No institution shall have more than one member
29	appointed to the commission. At least one of the members shall be appointed
30	from a Historically Black College or University.

1	(m) Four members appointed by the governor from the private sector in
2	an industry related to one or more of the critical infrastructure sectors
3	contained within the boundaries of the state of Louisiana.
4	(n) Two members appointed by the governor from local government who
5	have significant experience in emergency management operations.
6	(2) The members appointed by the governor shall serve for a term of
7	four years. If a vacancy occurs in the membership of the commission, the
8	vacancy shall be filled in the same manner in which the original appointment
9	was made. The members appointed pursuant to Subparagraphs (1)(a) through
10	(k) of this Subsection may authorize a designee to attend commission meetings.
11	C. The governor shall designate a chairman and co-chairman for the
12	commission. The chairman and co-chairman of the commission may invite
13	public officials or individuals from the private sector who, in the judgment of
14	the chairman or co-chairman, can provide valuable assistance to the
15	commission in the conduct of its duties.
16	D.(1) The members of the commission, or their designees, shall not
17	receive additional compensation nor per diem for their service on the
18	commission.
19	(2) Commission members who are employees or elected public officials
20	of the state or a political subdivision may seek reimbursement of travel expenses
21	from their employing government agency or elective office, in accordance with
22	state travel guidelines issued by the division of administration.
23	<u>§15.14. Purposes and powers of the commission</u>
24	A. The commission shall have the following purposes, duties, and
25	powers:
26	(1) Identify, prioritize, and mitigate Louisiana's cyber risk.
27	(2) Develop a cybersecurity strategy for the state and identify sources of
28	support for strategy implementation.
29	(3) Promote cybersecurity awareness and recommend best practices for
30	the security of all of Louisiana's cyber ecosystem.

1	(4) Promote actions, including legislative, administrative, and regulatory,
2	where appropriate, to enhance cybersecurity in Louisiana.
3	(5) Grow Louisiana's cybersecurity workforce and educate the public
4	and private sectors about cybersecurity.
5	(6) Enhance Louisiana cyber emergency preparedness and response
6	capabilities.
7	(7) Monitor, understand, and share cyber threat information.
8	(8) Build comprehensive digital forensics and cyber investigative
9	<u>capability.</u>
10	(9) Identify, prioritize, acquire, and establish funding mechanisms to
11	enhance Louisiana's cybersecurity efforts.
12	(10) Facilitate economic development by promoting a cyber-safe
13	Louisiana for businesses and consumers.
14	(11) Serve as an advisory body to the governor relating to all issues
15	relating to cybersecurity and protecting critical infrastructure.
16	B. In furtherance of its powers and duties, the commission may create
17	standing or special committees and rules necessary and proper to ensure
18	efficient accomplishment of its mission.
19	§15.15. Staffing of the commission; reports
20	A.(1) The Military Department, state of Louisiana shall provide the
21	primary staff to assist the commission in its duties and mission. The commission
22	may request the assistance of other state agencies, including but not limited to
23	the Governor's Office of Homeland Security and Emergency Preparedness, the
24	office of technology services of the division of administration, and the Louisiana
25	State Police.
26	(2) All state agencies and political subdivisions of the state shall
27	cooperate with the commission and its staff in implementing the provisions of
28	this Subpart.
29	B. The commission shall provide an annual report containing an
30	overview of goals, objectives, priorities, estimated completion dates of activities,
