2	To enact R.S. 36:259(B)(19) and Chapter 61 of Title 37 of the Louisiana Revised Statutes
3	of 1950, to be comprised of R.S. 37:3721 through 3726, relative to community health
4	workers; to create the Louisiana Community Health Worker Workforce Board within
5	the Louisiana Department of Health; to provide for the powers and duties of the
6	board; to provide for the board membership; to authorize the board to develop
7	training practices for community health workers; to provide for rulemaking
8	authority; to provide for termination of the board; to provide relative to board
9	governance; to provide relative to the powers and duties of the Louisiana Department
10	of Health with respect to the board and community health workers; and to provide
11	for related matters.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. R.S. 36:259(B)(19) is hereby enacted to read as follows:
14	§259. Transfer of agencies and functions to Louisiana Department of Health
15	* * *
16	B. The following agencies are placed within the Louisiana Department of
17	Health and shall exercise and perform their powers, duties, functions, and
18	responsibilities as otherwise provided by law:

1	Section 2. Chapter 61 of Title 37 of the Louisiana Revised Statutes of 1950,
2	comprised of R.S. 37:3721 through 3726, is hereby enacted to read as follows:
3	CHAPTER 61. LOUISIANA COMMUNITY HEALTH WORKER WORKFORCE
4	<u>§3721. Short Title</u>
5	This Chapter shall be known and may be cited as the "Louisiana Community
6	Health Worker Workforce Act".
7	<u>§3722. Definitions</u>
8	As used in this Chapter, except where the context clearly requires otherwise,
9	the following words and phrases shall have the following meanings:
10	(1) "Community health worker" means an individual who serves as a liaison
11	for community members to facilitate access to health and social services and to
12	improve quality and cultural competence of service delivery through outreach,
13	education, support, and advocacy. "Community health worker" does not include an
14	individual who provides clinical services.
15	(2) "Department" means the Louisiana Department of Health.
16	§3723. Community Health Worker Workforce Board
17	There is hereby created a Louisiana Community Health Worker Workforce
18	Board, hereafter referred to in this Chapter as the "board", within the Louisiana
19	Department of Health. It shall consist of eleven members to include a majority of
20	community health workers. The board shall consist of the following members:
21	(1) The director of the Community Health Worker Institute at Louisiana
22	State University Health Sciences Center at New Orleans or his designee.
23	(2) A member of the board of directors of the Louisiana Public Health
24	Institute or his designee.
25	(3) The secretary of the Louisiana Department of Health or his designee.
26	(4) The Medicaid executive director in this state or his designee.
27	(5) The chair of the Louisiana Community Health Outreach Network or his
28	designee.
29	(6) Six community health workers representing community-based
30	organizations. The six community health workers shall be appointed by the governor

1	from a list of community health workers recommended by the ten human services
2	districts and authorities provided in R.S. 28:912 and developed in consultation with
3	the Louisiana Community Health Outreach Network. The community health
4	workers shall represent all areas of the state, including rural areas.
5	§3724. Board powers and duties
6	A. The board shall meet twice a year. Members of the board shall serve
7	without compensation.
8	B. The Louisiana State University Health Science Center, Center for
9	Healthcare Value and Equity, shall provide staffing for the board.
10	C. The board shall develop all of the following:
11	(1) A recommended program to enhance employer readiness in hiring
12	community health workers.
13	(2) Recommendations for core skills, roles, and competencies for community
14	health workers in Louisiana.
15	(3) Recommended standards and requirements for community health worker
16	education and training programs, including recommended standards for community
17	health worker educators.
18	(4) Recommendations for sustainable methods of financing for community
19	health worker services.
20	D. The board may do all of the following:
21	(1) Review community health worker training programs.
22	(2) Make recommendations to community health worker training programs.
23	(3) Track employment of community health workers in Louisiana from
24	information provided voluntarily to the board by entities such as employers or
25	community-based organizations.
26	§3725. Department powers and duties
27	The department, in consultation with the board, may adopt rules pursuant to
28	the Administrative Procedure Act to implement core skills, roles, and competencies
29	for community health workers; to implement standards and requirements for

1	community health worker education and training programs; and to implement
2	standards for community health worker education.
3	<u>§3726. Termination</u>
4	The Board shall terminate operations on December 31, 2028.
5	Section 2. Notwithstanding any provision of law to the contrary, the Louisiana
6	Community Health Worker Workforce Board shall elect a chair at its first meeting.
