# COURTS: Provides relative to jurisdiction of city and parish courts over eviction proceedings

1	AN ACT		
2	To amend and reenact Code of Civil Procedure Article 4844 and R.S. 13:1443(B), relative		
3	to civil jurisdiction for parish and city courts; to remove the jurisdictional amounts		
4	in eviction proceedings; and to provide for related matters.		
5	Be it enacted by the Legislature of Louisiana:		
6	Section 1. Code of Civil Procedure Article 4844 is hereby amended and reenacted		
7	to read as follows:		
8	Art. 4844. Amount in dispute; eviction proceedings		
9	A. Except as otherwise provided in this Article, a parish court or city court		
10	shall have jurisdiction, concurrent with the district court, over suits by owners and		
11	landlords for the possession of leased premises as follows:		
12	(1) When the lease is by the day and the daily rental is one hundred fifty		
13	dollars or less.		
14	(2) When the lease is by the week and the weekly rental is five hundred		
15	dollars or less.		
16	(3) When the lease is by the month and the monthly rental is three thousand		
17	dollars or less.		
18	(4) When the lease is by the year and the annual rental is thirty-six thousand		
19	dollars or less.

1	(5) When the suit is to evict an occupant as defined by Article 4704, if the
2	annual value of the right of occupancy does not exceed the amount in dispute to
3	which the jurisdiction of the court is limited by Articles 4842 and 4843 or as to the
4	amounts set forth in Subparagraphs (3) and (4) of this Paragraph.
5	B. In the City Court of East St. Tammany, the city court shall have the same
6	jurisdictional limit for possession of leased premises in eviction proceedings as
7	provided for in Article 4912 for justice of the peace courts.
8	C. In the City Court of Hammond, the city court shall have jurisdiction over
9	suits by owners and landlords for the possession of leased premises when the lease
10	is by the month and the monthly rental is five thousand dollars or less.
11	D. In computing the jurisdictional amount for purposes of eviction suits, the
12	daily, weekly, monthly, annual, or other rental provided by the lease, exclusive of
13	interest, penalties, or attorney fees, shall determine the amount in dispute.
14	Notwithstanding Articles 4842(A) and 4843, a parish court or city court shall,
15	within its territorial jurisdiction, have jurisdiction, concurrent with the district court,
16	over the following matters, regardless of the amount of daily, monthly, or yearly rent
17	or the rent for the unexpired term of the lease or the annual value of the right of
18	occupancy:
19	(1) Suits by owners and landlords for the possession of leased premises.
20	(2) Suits by landowners or lessors for eviction of occupants or tenants of
21	leased residential premises.
22	(3) Suits to evict an occupant as defined by Article 4704.
23	(4) Suits by landowners or lessors for the eviction of occupants or tenants of
24	leased commercial premises and leased farmlands.
25	Section 2. R.S. 13:1443(B) is hereby amended and reenacted to read as follows:
26	§1443. Civil jurisdiction; amount in controversy; eviction suits; injunctive actions

28	B.(1) A parish court shall have jurisdiction, concurrent with the district
29	court, over suits by owners and landlords for the possession of leased premises

1	within its territorial jurisdiction, as follows: in accordance with Code of Civil
2	Procedure Article 4844.
3	(a) When the amount of the rental does not exceed the jurisdictional amounts
4	provided in Code of Civil Procedure Article 4844(A).
5	(b) When the suit is to evict an occupant, as defined by Article 4704 of the
6	Code of Civil Procedure, if the annual value of the right of occupancy does not
7	exceed the amount in dispute to which the jurisdiction of the court is limited by
8	Subsection A of this Section.
9	(2) In computing the jurisdictional amount for purposes of eviction suits, the
10	daily, weekly, monthly, annual, or other rental provided by the lease, exclusive of
11	interest, penalties, or attorney fees shall determine the amount in dispute.

Abstract: Removes the jurisdictional amounts for eviction proceedings in city and parish courts.

<u>Present law</u> provides that a parish court or city court shall have jurisdiction, concurrent with the district court, in eviction proceedings based on the value of the lease or the annual value of the right of occupancy.

<u>Present law</u> provides that the City Court of East St. Tammany is concurrent with the district court in cases where the amount in dispute or the value of the property involved does not exceed \$50,000, and over suits by owners and landlords of leased premises.

<u>Present law</u> authorizes the City Court of Hammond to have jurisdiction over suits by owners and landlords for the possession of leased premises when the lease is by the month and the monthly rental is \$5,000 or less.

<u>Proposed law</u> removes the jurisdictional amounts for eviction proceedings in city and parish courts, and provides that a parish court or city court shall, within its territorial jurisdiction, have jurisdiction, concurrent with the district court, over the following matters, regardless of the amount of daily, monthly, or yearly rent or the rent for the unexpired term of the lease or the annual value of the right of occupancy:

- (1) Suits by owners and landlords for the possession of leased premises.
- (2) Suits by landowners or lessors for eviction of occupants or tenants of leased residential premises.

- (3) Suits to evict an occupant as defined by Article 4704.
- (4) Suits by landowners or lessors for the eviction of occupants or tenants of leased commercial premises and leased farmlands.
