PUBLIC MEETINGS: Requires certain public bodies to broadcast meetings live via television or the internet

AN ACT

2	To amend and reenact R.S. 42:23 and to enact R.S. 42:19(A)(1)(c), relative to broadcasts
3	of public meetings; to require certain public bodies to broadcast meetings live; to
4	require certain information on the notice of the meeting; to provide definitions; and
5	to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 42:23 is hereby amended and reenacted and R.S. 42:19(A)(1)(c) is
8	hereby enacted to read as follows:

12	(c) Each public body subject to R.S. 42:23(B)(2) shall include on its written
13	public notice sufficient information to enable the public to locate the broadcast for

17	A. All of the proceedings in a public meeting may be video or tape recorded,

1	B.(1) Each nonelected board or commission that has the authority to levy a
2	tax shall video or audio record, film, or broadcast live all proceedings in a public
3	meeting.
4	(2)(a)(i) The parish governing authority in a parish with a population of
5	twenty-five thousand or more shall broadcast live all of its proceedings in public
6	meetings, including the parish governing authority's committee meetings.
7	(ii) Each school board in a parish with a population of twenty-five thousand
8	or more shall broadcast live all of its proceedings in public meetings, including the
9	school board's committee meetings.
10	(iii) Each governing authority of a municipality with a population of ten
1	thousand or more shall broadcast live all its proceedings in public meetings,
12	including the governing authority's committee meetings.
13	(b) For purposes of this Paragraph, "broadcast live" means the publicly
14	available distribution of audio and video of a meeting in real or near real time via the
15	internet or television broadcast.
16	(c) The failure of a public body to broadcast live as required by this
17	Paragraph due to a technological failure beyond the control of the public body or
18	beyond its ability to resolve timely is not a violation of the provisions of this
19	Chapter.
20	(d) The requirement in this Paragraph for a public body to broadcast its
21	meetings does not apply to any executive session held in accordance with this
22	Chapter.
23	B. C. A public body shall establish standards for the use of lighting,
24	recording, or broadcasting equipment to insure proper decorum in a public meeting.

Abstract: Requires each school board and parish governing authority in a parish with a population of 25,000 or more and each governing authority of a municipality with a population of 10,000 or more to broadcast live all its public meetings.

<u>Present law</u> provides that all of the proceedings in a public meeting may be video or tape recorded, filmed, or broadcast live. Requires nonelected boards or commissions that have the authority to levy a tax to video or audio record, film, or broadcast live all proceedings in a public meeting. Further requires a public body to establish standards for the use of lighting, recording, or broadcasting equipment to insure proper decorum in a public meeting.

<u>Proposed law</u> retains <u>present law</u> and further requires each school board and parish governing authority in a parish with a population of 25,000 or more and each governing authority of a municipality with a population of 10,000 or more to broadcast live all its public proceedings in meetings, including its committee meetings. Defines "broadcast live" as the publicly available distribution of audio and video of the meeting in real or near real time via the internet or television broadcast. Further excludes executive sessions from the requirement to broadcast live and provides that the failure of a public body subject to <u>proposed law</u> to broadcast live due to a technological failure beyond the control of the public body or its ability to resolve timely shall not be a violation of <u>present and proposed law</u> (Open Meetings Law).

<u>Present law</u> requires all public bodies, except the legislature and its committees and subcommittees, to give written public notice of any regular, special, or rescheduled meeting no later than 24 hours before the meeting, exclusive of Saturdays, Sundays, and legal holidays. Requires the notice to include the agenda, date, time, and place of the meeting and provides that the agenda may not be changed less than 24 hours prior to the meeting, exclusive of Saturdays, Sundays, and legal holidays. Provides that each item on the agenda must be listed separately and described with reasonable specificity.

<u>Proposed law</u> further requires public bodies subject to the requirement to broadcast live to include on its meeting notice sufficient information to enable the public to locate the broadcast for viewing.
