SCHOOLS: Authorizes school boards to provide for chaplains to serve in public schools as employees or on a volunteer basis

AN ACT

2 To enact R.S. 17:2115.12, relative to school chaplains; to authorize each public school board 3 to provide for the service of chaplains at its schools; to provide that chaplains may 4 be employees or serve on a volunteer basis; to provide that student and employee 5 participation with a chaplain's programs or services is optional; to subject chaplains 6 to criminal history laws applicable to school employees and school volunteers; to 7 require any school board providing for chaplains to adopt policies relative to their 8 service; and to provide for related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. R.S. 17:2115.12 is hereby enacted to read as follows: 11 §2115.12. School chaplains 12 A. Each local public school board may provide for the service of a chaplain 13 at any school under its jurisdiction. The school board may hire chaplains as school 14 employees or authorize them to serve on a volunteer basis. 15 B. Participation by any student or employee in any program or service 16 offered by the chaplain is optional. 17 C. A school chaplain is subject to all criminal history laws and policies that are applicable to other school employees and school volunteers, as applicable, 18 19 including but not limited to R.S. 15:587.1 and R.S. 17:15.

**Abstract:** Authorizes schools boards to provide for chaplains to serve in public schools as employees or on a volunteer basis.

<u>Proposed law</u> authorizes school boards to provide for the service of school chaplains as employees or volunteers; provides that participation in a chaplain's programs or services is optional; subjects chaplains to all <u>present law</u> relative to criminal history of school employees and volunteers; and requires school boards with chaplains to adopt policies for proposed law implementation.
