SCHOOLS/EMPLOYEES: Provides relative to sick leave banks for teachers, bus operators, and other school employees

1	AN ACT
2	To amend and reenact R.S. 17:500.2(F), 1202(F), and 1206.2(F), relative to sick leave banks
3	for school employees; to authorize employees to donate leave directly to other
4	employees; to require a certain percentage of leave balances to be retained in sick
5	banks; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 17:500.2(F), 1202(F), and 1206.2(F) are hereby amended and
8	reenacted to read as follows:
9	§500.2. School bus operators; extended sick leave

11	F.(1) Each city, parish, and other local public school board shall develop and
12	implement a sick leave bank policy to allow for the donation of sick leave among
13	school bus operators.
14	(2) A school bus operator may donate sick leave directly to another school
15	bus operator in an amount not to exceed one-half of the donating bus operator's
16	accumulated leave as calculated at the beginning of the school year.
17	(3) At least ninety percent of the leave balance in the bank shall be retained
18	in the bank from one school year to the next.

Abstract: Relative to sick leave banks for school employees, allows direct employee-toemployee donations and requires the retention of a certain percentage of the leave balance in the bank from school year to school year. <u>Present law</u> requires public school boards to provide a sick leave bank policy to allow for the donation of sick leave among employees (applicable to teachers, bus operators, and other employees).

Proposed law:

- (1) Authorizes an employee to donate a certain amount of his sick leave directly to another employee.
- (2) Requires that at least 90% percent of the bank's leave balance be retained from one school year to the next.

(Amends R.S. 17:500.2(F), 1202(F), and 1206.2(F))
