## SENATE CONCURRENT RESOLUTION NO. 2

## BY SENATOR ABRAHAM

CONGRESS. Memorializes Congress to call for a convention of states to amend the United States Constitution to establish a limitation on terms for the members of congress.

1	A CONCURRENT RESOLUTION
2	To memorialize the United States Congress to call a convention of states for the purpose of
3	proposing amendments to set a limit on the number of terms that a person may be
4	elected as a member of the United States House of Representatives and to set a limit
5	on the number of terms that a person may be elected as a member of the United
6	States Senate.
7	BE IT RESOLVED that the Legislature of Louisiana does hereby proffer and endorse
8	all of the following:
9	Section 1. The Legislature of Louisiana hereby makes an application to Congress,
10	as provided by Article V of the Constitution of the United States of America, to call a
11	convention limited to proposing an amendment to the Constitution of the United States of
12	America to set a limit on the number of terms that a person may be elected as a member of
13	the United States House of Representatives and to set a limit on the number of terms that a
14	person may be elected as a member of the United States Senate.
15	Section 2. The secretary of state is hereby directed to transmit copies of this
16	application to the president and secretary of the Senate of the United States and to the
17	speaker, clerk, and judiciary committee chairman of the House of Representatives of the
18	Congress of the United States, and copies to the members of the said Senate and House of

Representatives from this state; also to transmit copies hereof to the presiding officers of 1 2 each of the legislative houses in the several states, requesting their cooperation. 3 Section 3. This application shall be considered as covering the same subject matter 4 as the applications from other states to Congress to call a convention to set a limit on the number of terms that a person may be elected to the House of Representatives of the 5 6 Congress of the United States and the Senate of the United States; and this application shall 7 be aggregated with same for the purpose of attaining the two-thirds of states necessary to 8 require Congress to call a limited convention on this subject, but shall not be aggregated with 9 any other applications on any other subject. 10 Section 4. This application constitutes a continuing application in accordance with 11 Article V of the Constitution of the United States of America until the legislatures of at least 12 two-thirds of the several states have made applications on the same subject. 13 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 14 secretary of state.
