21	B. (1) Except as provided by Paragraph (2) of this Subsection, a
22	governmental entity or business shall not implement, order, or impose a mandate
23	requiring a person to wear a face covering to prevent the spread of COVID-19.
24	(2) The provisions of this Subsection shall not apply to the following:
25	(a) A nursing facility as defined by R.S. 40:2009.2.
26	(b) A correctional facility as defined by R.S. 14:402.

4	C. (1) Except as provided by Paragraph (2) of this Subsection, a
5	governmental entity or business shall not implement, order, or impose a mandate
6	requiring a person to be vaccinated against COVID-19.
7	(2) The provisions of this Subsection shall not apply to the following:
8	(a) Hospitals as defined by R.S. 40:2102, or nursing facilities as defined by
9	R.S. 40:2009.2, if the Centers for Medicare and Medicaid Services mandate that
10	patient care employees in hospitals or nursing facilities receive the COVID-19
11	vaccination.
12	(b) Religious accommodations in accordance with Title VII of the 1964 Civil
13	Rights Act.
14	(c) A physician's office.
15	(d) An EMS practitioner as defined by R.S. 40:1131(15).
16	D. A person may file a petition requesting that the attorney general seek
17	injunctive relief if a governmental entity violates the provisions of this Section. In
18	an injunction issued pursuant to a violation of this Section, a court may include
19	reasonable requirements to prevent further violations of this Section.
20	E. A violation of this Section shall be fined in accordance with the following.
21	All fines in violation of this section shall include reasonable cost of investigation and
22	attorney fees while the attorney general investigates and prosecutes any accused
23	violation of this Section.
24	(1) A governmental entity shall be fined fifty thousand dollars for each
25	violation of this Section.
26	(2) A small business as defined by the Small Business Administration shall
27	be fined ten thousand dollars for each violation of this Section.
28	(3) A large business shall be fined fifty thousand dollars for each violation
29	of this Section."
