## HEALTH CARE: Establishes procedures for the use of artificial intelligence by healthcare entities

1	AN ACT
2	To enact R.S. 37:23.5, relative to use of artificial intelligence by healthcare entities and
3	professionals; to establish procedures for the use of artificial intelligence in health
4	care; to provide for definitions; to provide for the promulgation of rules; and to
5	provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 37:23.5 is hereby enacted to read as follows:
8	§23.5. Artificial intelligence; procedures
9	A. A healthcare entity shall not make any decision regarding the care of
10	patients based solely on the results derived from the use or application of artificial
11	intelligence.
12	B. A healthcare professional shall review any healthcare decision made by
13	or with the use of artificial intelligence in accordance with procedures established
14	by the board governing his profession. The healthcare professional may override any
15	decision made by an artificial intelligence.
16	C. Any board responsible for licensing a healthcare professional in
17	accordance with this Title shall promulgate rules to establish standards necessary to
18	implement the provisions of this Section.
19	D. As used in this Section:

1	(1) "Artificial intelligence" means an artificial system developed in computer
2	software, physical hardware, or other context that solves tasks requiring human-like
3	perception, cognition, planning, learning, communication, or physical action.
4	(3) "Healthcare entity" means a hospital, a provider-sponsored organization,
5	a health maintenance organization, a health insurance plan, or any other kind of
6	health care facility, organization, or plan.
7	(2) "Healthcare professional" means any professional licensed in accordance
8	with this Title that provides healthcare services.

**Abstract:** Establishes protections and guidelines for healthcare entities and healthcare professionals providing health care and utilizing artificial intelligence.

<u>Proposed law</u> prohibits a healthcare entity from making a healthcare decision solely on the basis of artificial intelligence.

<u>Proposed law</u> requires a healthcare professional to review decisions made solely by an artificial intelligence. A healthcare professional shall have the authority to override a decision made solely by an artificial intelligence.

<u>Proposed law</u> tasks the professional boards of healthcare professionals with promulgating rules necessary to implement the provisions of this <u>proposed law</u>.

Proposed law provides for definitions.
