19	determined by the board in this state under state law.
20	(6) The applicant does not have a disciplinary action or investigation
21	pending in another state. If the applicant has a disciplinary action or
22	investigation pending, the board in this state shall not issue or deny an
23	occupational license or certification to the person until the disciplinary action
24	or investigation is resolved or the person otherwise meets the criteria for an
25	occupational license or certification in this state to the satisfaction of the board
26	in this state.
27	(7) The applicant pays all applicable fees in this state.
28	(8) The applicant lives in this state and provides proof of residency as
29	outlined in R.S. 37:53.
30	<b>B.</b> If another state issued the applicant a certification, but this state
31	requires an occupational license to work, the board in this state shall issue an
32	occupational license to the applicant if the applicant otherwise satisfies
33	Subsection A of this Section.
34	<u>§53. Residency</u>
35	For purposes of this Chapter, residency may be established by producing
36	proof of one of the following:
37	(1) A current state-issued identification card.
38	(2) A state-issued voter registration card.
39	(3) Documentation of current in-state employment or notarized letter
40	of promise of employment of the applicant or his spouse. If an applicant uses
41	<u>this method to obtain licensure, a board shall require another form of proof of</u>
42	residency listed in this Section, six months after licensure is granted.
43	(4) A current homestead exemption for this state."
