EG NO IMPACT See Note Requires in-service training for school nurses on caring for students with sickle cell disease

Proposed legislation requires that school nurses in public schools, including charter schools, participate in an in-service training program related to caring for students with sickle cell disease, including: disease symptoms and treatment; medical needs of, and possible accommodations for, affected students; and communication with parents and other school personnel to support positive academic outcomes for such students. Further requires the Louisiana Sickle Cell Commission to provide instructional materials to the Louisiana Department of Education (LDOE) and requires LDOE to provide such materials to school boards for use in training.

## **EXPENDITURE EXPLANATION**

The Louisiana Department of Health (LDH) provided that the Louisiana Sickle Cell Commission, which is under the Office of Public Health, Bureau of Family Health, can generate and submit training materials to LDOE electronically, at no cost to the department.
