HOUSE RESOLUTION NO. 119

AGRICULTURE: Authorizes and requests the chairman of the House Committee on Agriculture, Forestry, Aquaculture and Rural Development to appoint a subcommittee to study and address the devastation of the forest industry due to the infestation of beetles

A RESOLUTION

2	To authorize and request the chairman of the House Committee on Agriculture, Forestry,
3	Aquaculture, and Rural Development to appoint a subcommittee, entitled the
4	Louisiana Emergency Beetle Committee, to study and make recommendations on
5	rules and actions to address the devastation of the forest industry due to the recent
6	drought and infestation of beetles and other pests that are killing pine and other trees
7	and to address issues arising from any laws or regulations that restrict or prohibit
8	local and state entities from removing infested trees from private properties.
9	WHEREAS, according to an article published by the Louisiana State University
10	AgCenter and the Office of Research and Economic Development, the forest industry is the
11	top agricultural sector in Louisiana worth ten to fourteen billion dollars, making it a
12	substantial economic contributor to the state's economy every year and is one of the biggest
13	job creators in Louisiana, creating approximately thirty-seven thousand jobs in this state; and
14	WHEREAS, more than half of all land in Louisiana is comprised of forests that are
15	heavily dominated by pines; and
16	WHEREAS, forests are continually threatened by natural disasters, invasive species,
17	diseases, and other factors; and
18	WHEREAS, due to the recent drought in this state and increasing drought frequency
19	with extreme heat, pines and other trees have become more vulnerable to beetle and pest
20	infestation; and

WHEREAS, the National Drought Mitigation Center has categorized a substantial
portion of Louisiana's parishes as being in an "exceptional drought" state for extended
periods of time which causes trees to weaken and become more susceptible to various issues,
especially to pests and diseases; and
WHEREAS, according to the United States Department of Agriculture Forest
Service, Ips beetles and other types of beetles and pests are prevalent in the south, usually
attacking weakened, dying, or recently felled trees and fresh logging debris; and
WHEREAS, research conducted in the southeastern United States revealed that pines
are sensitive to droughts, and trees damaged from a drought may take several years to fully
regain their health and vigor, which may worsen forest conditions or increase the risk of
infestations of beetles and other pests; and
WHEREAS, natural disasters, such as prolonged droughts, sometimes result in high
numbers of dead and weakened trees on private properties near right-of-ways, resulting in
dangerous conditions despite good preventative measures; and
WHEREAS, these trees not only contribute to the beetle infestation in this state but
also create danger to people and infrastructure when not removed and handled promptly; and
WHEREAS, the Louisiana Department of Environmental Quality has created
regulations for tree removal in certain situations which may burden arborists or other tree
removal specialists as well as private citizens who may bear the costs associated with tree
removal; and
WHEREAS, many infested trees are on private properties near public right-of-ways
and roads; however, local and municipal entities are unable to cut or remove such trees on
private properties due to current legal restrictions despite the danger to homeowners,
utilities, and person traveling upon public roads and right-of-ways.
WHEREAS, the interests of the citizens of the state of Louisiana would be served
by the creation of a subcommittee of the House Committee of Agriculture, Forestry,
Aquaculture, and Rural Development to study and recommend rules and actions to address
items and issues including, but not limited to, the following:

Forest devastation caused by beetle infestation.

- 9 THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 10 Legislature of Louisiana does hereby authorize and request the chairman of the House
- 11 Committee of Agriculture, Forestry, Aquaculture, and Rural Development to appoint a
- subcommittee, entitled as the Louisiana Emergency Beetle Committee, study and make
- 13 recommendations on rules and actions to address the devastation of the forest industry due
- 14 to the recent drought and infestation of beetles and other pests that are killing pine and other
- trees and to address issues arising from any laws or regulations that restrict or prohibit local
- and state entities from removing infested trees from private properties.
- BE IT FURTHER RESOLVED that the chairman of the House Committee on
- 18 Agriculture, Forestry, Aquaculture, and Rural Development shall appoint the members of
- 19 the subcommittee.
- BE IT FURTHER RESOLVED that the state representative for House District 27
- 21 shall serve as the chairman of the subcommittee.
- BE IT FURTHER RESOLVED that the subcommittee shall solicit the input,
- 23 recommendations, and advice of the following entities:
- 24 (1) The Louisiana Department of Agriculture and Forestry.
- 25 (2) The Louisiana Public Service Commission.
- 26 (3) The Louisiana Forestry Association.
- 27 (4) The Police Jury Association of Louisiana.
- 28 (5) The Louisiana Municipal Association.
- 29 (6) The Louisiana Department of Environmental Quality.
- 30 (7) The Louisiana Division of Administration.

(8) The office of the governor.

2	(9) The Louisiana Loggers Association.
3	(10) The Louisiana Department of Insurance.
4	BE IT FURTHER RESOLVED that the members of the subcommittee shall advocate
5	to support the Congressional bill, S.3838 of the 118th Congress (2024), also known as the
6	Emergency Beetle Response Act of 2024 and request the Louisiana Congressional
7	Delegation support this Resolution and all other Congressional instruments that address the
8	solutions and remedies of this dangerous and growing beetle infestation issue.
9	BE IT FURTHER RESOLVED that the subcommittee shall also focus its study on
10	raising public awareness on beetle infestation, the dangers associated with it, and making
11	recommendations on prevention or remediation.
12	BE IT FURTHER RESOLVED that members of the subcommittee shall serve
13	without compensation, except per diem or expense reimbursement to which they may be
14	individually entitled as members of their constituent organizations.
15	BE IT FURTHER RESOLVED that the subcommittee shall convene its first meeting
16	no later than August 1, 2024, at the call of the chairman of the subcommittee, and the
17	subcommittee shall hold such meetings as may be necessary to fulfill its duties.
18	BE IT FURTHER RESOLVED that at the first meeting, the subcommittee shall elect
19	a vice chairman and other officers as it deems appropriate.
20	BE IT FURTHER RESOLVED that the House Committee on Agriculture, Forestry,
21	Aquaculture, and Rural Development shall provide staff assistance to the subcommittee upon
22	the request of the chairman of the subcommittee.
23	BE IT FURTHER RESOLVED that the subcommittee shall submit a report of its
24	findings and recommendations of rules and actions on or before January 15, 2025, to the
25	House Committee on Agriculture, Forestry, Aquaculture, and Rural Development, the
26	commissioner of the Department of Agriculture and Forestry, and the David R. Poynter
27	Legislative Research Library.
28	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
29	commissioner of the Louisiana Department of Agriculture and Forestry.

Authorizes and requests the chairman House Committee of Agriculture, Forestry, Aquaculture, and Rural Development to appoint a subcommittee, entitled the La. Emergency Beetle Committee, to study and recommend rules and actions to address forest devastation caused by beetle infestation, problems related to dead trees on private properties near power lines and other issues and effects on public rights-of-way caused by the danger and effects of such dead trees, and to consider whether certain regulations by the Dept. of Environmental Quality may be suspended during emergency situations caused by natural disasters.

Requires the chairman of the House Committee on Agriculture, Forestry, Aquaculture, and Rural Development to appoint the members of the subcommittee.

Requires the state representative for House District 27 to serve as the chairman of the subcommittee.

Requires the subcommittee to solicit the input, recommendation, and advice of the following entities:

- (1) The La. Department of Agriculture and Forestry.
- (2) The La. Public Service Commission.
- (3) The La. Forestry Association.
- (4) The Police Jury Association of La.
- (5) The La. Municipal Assoc.
- (6) The La. Department of Environmental Quality.
- (7) The La. Division of Administration.
- (8) The office of the governor.
- (9) The La. Loggers Assoc.
- (10) The La. Department of Insurance.

Requires the subcommittee to advocate in support of the Congressional bill, S. 3838 of the 118th Congress of 2024, also known as the Emergency Pine Beetle Response Act of 2024, and to request the La. Congressional Delegation to support such Act as well as any other Congressional instrument that address the issue of beetle infestation.

Requires the subcommittee to also focus its study on raising public awareness on beetle infestation, the dangers of it, and making recommendations on prevention or a remediation plan.

Requires members of the subcommittee to serve without compensation, except per diem or expense reimbursement to which they may be individually entitled to.

Requires the subcommittee to convene its first meeting no later than Aug. 1, 2024, at the call of the chairman of the subcommittee, and the subcommittee to hold such meetings as may be necessary to fulfill its duties. Requires the subcommittee to elect a vice chairman and other officers as it deems appropriate at the first meeting.

Requires the House Committee on Agriculture, Forestry, Aquaculture, and Rural Development to provide staff assistance to the commission upon the request of the chairman of the subcommittee.

Requires the subcommittee to submit a report of its findings and recommendations of rules and actions by Jan. 15, 2025, to the House Committee on Agriculture, Forestry, Aquaculture, and Rural Development, the commissioner of the La. Dept. of Agriculture and Forestry, and the David R. Poynter Legislative Research Library.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Agriculture</u>, Forestry, Aquaculture, and Rural Development to the original bill:

1. Make a technical change.
