2 To enact R.S. 40:1501.9, relative to Caddo Parish Fire District No. 6; to authorize the district 3 to levy a sales and use tax, subject to voter approval; and to provide for related 4 matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 40:1501.9 is hereby enacted to read as follows: 7 §1501.9. Caddo Parish Fire District No. 6; authority to levy sales and use tax 8 A. Notwithstanding any other provision of law to the contrary, Caddo Parish 9 Fire District No. 6 may levy and collect a sales and use tax not to exceed one percent 10 pursuant to the provisions of Article VI, Section 30 of the Constitution of Louisiana. 11 Caddo Parish Fire District No. 6 may levy the tax only if the levy of the tax is 12 approved by a majority of the qualified electors of the district voting on the 13 proposition at an election held for that purpose and conducted in accordance with the 14 Louisiana Election Code and held on a date that corresponds with an election date 15 provided by R.S. 18:402(A)(1) or (B)(1). 16 B. The proceeds of the tax authorized by this Section shall be used for maintaining and operating fire protection facilities, for obtaining water for fire 17 18 protection purposes, or for any other lawful purpose as determined by the governing

2	C. The sales and use tax so levied shall be imposed by an ordinance of the
3	district and shall be levied upon the sale at retail, the use, the lease or rental, the
4	consumption, the storage for use or consumption of tangible personal property, and
5	on sales of services in the district, all as defined in Chapter 2 of Subtitle II of Title
6	47 of the Louisiana Revised Statutes of 1950.
7	D. The tax shall be in addition to all other authorized sales and use taxes and
8	shall be collected at the same time and in the same manner as other local sales and
9	uses taxes.
10	Section 2. Notwithstanding the provisions of R.S. 40:1501.9(A) as enacted by this
11	Act, the governing authority of Caddo Parish Fire District No. 6 may, in 2025 only, call the
12	election provided for in R.S. 40:1501.9(A) on a date that corresponds with an election date
13	provided by R.S. 18:402(F).

**Abstract:** Authorizes Caddo Parish Fire District No. 6 to levy and collect a sales and use tax not to exceed 1% subject to voter approval.

<u>Present law</u> establishes Caddo Parish Fire District No. 6 and provides for its purpose, functions, and authority.

<u>Proposed law</u> authorizes Caddo Parish Fire District No. 6 to levy a sales and use tax not to exceed 1%, subject to voter approval. Provides that proceeds shall be used for any lawful purpose.

<u>Proposed law</u> requires the tax proposition to appear on a ballot at an election conducted in accordance with the La. Election Code and held on a date the corresponds with the dates of either gubernatorial or congressional elections. However, for 2015, authorizes Caddo Parish Fire District No. 6 to call the election provided for in <u>proposed law</u> on any election date available for bond, tax, or other proposition elections.
