Purpose of Bill: The bill requires the DA in Sabine and Winn Parishes to pay health insurance or Medicare supplemental insurance premiums for eligible retired employees. Eligibility is determined by the retiree's age, in accordance with the Parochial Employees' Retirement System of Louisiana and Medicare requirements, with retirees being required to enroll in Medicare and obtain a supplemental plan.
