13	relative to the construction, design, equipment, and operation of school buses
14	used in the transportation of students, the board also shall adopt rules and
15	regulations in accordance with the Administrative Procedure Act and any
16	applicable federal standards to require the following:
17	(1) On and after August 1, 2024, every new or used school bus purchased

1 by the governing authority of each public elementary and secondary school and 2 each nonpublic elementary and secondary school used primarily for the 3 transportation of students shall be equipped with passenger compartment 4 heating and air conditioning systems. (2) On and after August 1, 2027, every school bus used primarily for the 5 transportation of students shall be equipped with passenger compartment 6 7 heating and air conditioning systems. 8 B. Notwithstanding any provision of R.S. 17:164 to the contrary, the 9 State Board of Elementary and Secondary Education shall require each 10 governing authority of each public elementary and secondary school and each 11 nonpublic elementary and secondary school approved by the board to comply 12 with the rules and regulations adopted by the board pursuant to the provisions 13 of Subsection A of this Section. Section 2. This Act shall become effective upon signature by the governor or, if not 14 signed by the governor, upon expiration of the time for bills to become law without signature 15 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 16 vetoed by the governor and subsequently approved by the legislature, this Act shall become 17 18 effective on the day following such approval. Proposed law requires BESE to adopt rules and regulations (in accordance with the APA and any applicable federal standards) to require the following:

- (1) On and after August 1, 2024, every new or used school bus purchased by the governing authority of each public elementary and secondary school and each nonpublic elementary and secondary school used primarily for the transportation of students be equipped with passenger compartment heating and air conditioning systems.
- On and after August 1, 2027, every school bus used primarily for the transportation (2) of students shall be equipped with passenger compartment heating and air conditioning systems.

Proposed law provides that notwithstanding certain provisions of present law relative to the

construction, design, equipment, and operation of school buses, BESE must require each governing authority of each public elementary and secondary school and each nonpublic elementary and secondary school approved by the board to comply with such rules and regulations.

## Summary of Amendments Adopted by Senate

## <u>Committee Amendments Proposed by Senate Committee on Finance to the engrossed bill</u>

- 1. Requires BESE to adopt rules to require that on and after August 1, 2024, every new or used school bus purchased by the governing authority of each public elementary and secondary school and each nonpublic elementary and secondary school be equipped with heating and air conditioning systems.
- 2. Requires BESE to adopt rules to require that on and after August 1, 2027, every school bus used primarily for the transportation of students shall be equipped with heating and air conditioning systems.
