Provides relative to fantasy sports contests and sports wagering

Proposed legislation provides for an independent evaluation of fantasy sports contests. This measure establishes criteria by which the Gaming Control Board approves individuals to act as an independent evaluator of fantasy sports contests. Proposed legislation provides for the duties of the independent evaluator as well as mandates individuals to apply annually to the board. Proposed law requires the board to identify and accredit independent evaluators within 9 months. Once accreditation of an independent evaluator has occurred, this measure allows for fantasy sports contest licensees, experts or influencers, and content partners to have 9 months to contract directly with an independent evaluator. This instrument establishes cost of services to fantasy sports contest licensees shall not exceed 1% of the annual gross gaming revenue for both fantasy sports contests and sports wagers and shall be dispersed among licensees at the discretion of the board. This measure requires licensees to contract with and pay the accredited independent evaluator directly. This measure provides new and enhanced definitions.
