1	AN ACT
2	To amend and reenact R.S. 17:500.2(F), 1202(F), and 1206.2(F), relative to sick leave banks
3	for school employees; to authorize employees to donate leave directly to other
4	employees; to require a certain percentage of leave balances to be retained in sick
5	banks; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 17:500.2(F), 1202(F), and 1206.2(F) are hereby amended and
8	reenacted to read as follows:
9	§500.2. School bus operators; extended sick leave
10	* * *
11	F.(1) Each city, parish, and other local public school board shall develop and
12	implement a sick leave bank policy to allow for the donation of sick leave among
13	school bus operators.
14	(2) A school bus operator may donate sick leave directly to another school
15	bus operator in an amount not to exceed one-half of the donating bus operator's
16	accumulated leave as calculated at the beginning of the school year.
17	(3) At least ninety percent of the leave balance in the bank shall be retained
18	in the bank from one school year to the next.
