COLLEGES/UNIVERSITIES. Provides for mental health days for faculty, staff, and students in public education institutions. (8/1/25)

1	AN ACT
2	To amend and reenact R.S. 17:1208 and to enact R.S. 17:226(C), 1208.1(D), and 3312.1,
3	relative to absences for leave of mental health days; to provide relative to faculty,
4	staff, and students; to provide for excused absences for students; to provide for proof
5	related to the absences under certain circumstances; to provide for a definition; and
6	to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:1208 is hereby amended and reenacted and R.S. 17:226(C),
9	1208.1(D), and 3312.1 are hereby enacted to read as follows:
10	§226. Exemptions from compulsory attendance
11	* * *
12	C.(1) Children who are mentally stressed and may be suffering from
13	stress, anxiety, or emotional exhaustion and whose attendance in school may
14	endanger their academic performance shall be allowed to be absent from school
15	for not more than two days per semester.
16	(2) A parent or legal guardian of a student may request a mental health
17	day by submitting a notification in writing, by hand delivery or electronic mail,

1	to the student's school principal or counselor at least twenty-four hours in
2	advance. Requests on the day of absence are permitted for emergencies. Upon
3	the child's return to school, a doctor's or mental health professional's excuse
4	note is not required for using a mental health day unless absences exceed two
5	days per semester.
6	(a) Mental health days cannot be used on test dates, project deadlines,
7	or during final exams unless a valid medical or psychological emergency is
8	documented.
9	(b) Any school work the student misses due to the mental health absence
10	shall be made up before the semester ends.
11	(3) For purposes of this Subsection "mental health day" means a day off
12	to address mental health concerns, such as stress, anxiety, or emotional
13	exhaustion, without requiring a traditional medical illness.

15	§1208. Amount of personal leave
16	A. Every teacher employed by a parish or city school board of this state,
17	except those employees who receive annual leave, shall be entitled to and shall be
18	allowed to use up to two days absence during each school year to be used for such
19	purposes as may be determined by the individual teacher without loss of pay. The
20	teacher requesting such leave shall give his principal at least twenty-four hours
21	notice prior to taking the leave without loss of pay. Personal leave shall be charged
22	to and deducted from the teacher's sick leave for the current year or sick leave
23	accumulated as provided in R.S. 17:1201. Personal leave shall not be accumulated
24	from year to year, nor shall personal leave be compensated for upon death or
25	retirement or paid in any other manner except as provided for in this Section.
26	B.(1) Every teacher employed by a city, parish, or other local school
27	board of this state shall be entitled to and shall be allowed to use up to two days
28	absence during each school semester to be used for mental health days without
29	loss of pay. The teacher requesting such leave shall give his principal at least

21	§3312.1. Use of mental health leave
22	A. Notwithstanding any other provision of law to the contrary, each
23	board vested with management and supervision of colleges and universities shall
24	provide and allow all unclassified and academic personnel to use up to two days
25	absence during each semester to be used for mental health days without loss of
26	pay. The employee requesting such leave shall give his immediate supervisor of
27	the postsecondary institution where he is employed at least twenty-four hours
28	notice prior to taking the leave without loss of pay. In cases of emergencies,
29	notice can be given on the day of absence, subject to existing policies of the

1 institution.

B. For purposes of this Section "mental health day" means a day off to

address mental health concerns, such as stress, anxiety, or emotional

Proposed law provides for excused absences of faculty, staff, and students who take off from school or work for two mental health days per semester.

Proposed law provides for a parent or legal guardian of a student to request a mental health day by submitting a notification in writing, by hand delivery or electronic mail, to the student's school principal or counselor at least 24 hours in advance. Additionally, proposed law allows requests on the day of absence to be permitted for emergencies.

Proposed law mandates that every teacher employed by a city, parish, or other local school board of this state to be entitled to and allowed to be absent up to two days during each school semester for mental health days without loss of pay. Furthermore, the teacher requesting such leave must give his principal at least 24 hours notice prior to taking the leave without loss of pay; however, in cases of emergencies, notice can be given on the day of absence, subject to existing school board policies.

Proposed law mandates that all employees, as defined in present law, employed by a city, parish, or other local school board of this state must allowed to be absent up to two days during each school semester for mental health days without loss of pay. Furthermore, the employee requesting such leave shall give the principal of the school where he is employed at least 24 hours notice prior to taking the leave without loss of pay; however, in cases of emergencies, notice can be given on the day of absence, subject to existing school board policies.

Proposed law mandates that each board vested with management and supervision of colleges and universities must provide and allow all unclassified and academic personnel to use up to two days of leave during each semester to be used for mental health days without loss of pay. Furthermore, proposed law provides that the employee requesting leave must give his immediate supervisor at least 24 hours notice prior to taking the leave without loss of pay and in cases of emergencies, notice can be given on the day of absence, subject to existing school board policies.

Proposed law defines mental health days as a day off to address mental health concerns, such as stress, anxiety, or emotional exhaustion, without requiring a traditional medical illness.

Effective August 1, 2025.
