The proposition shall be comprised of simple, unbiased, concise, and easily understood language and be in the form of a question. The proposition shall not exceed two hundred words in length and shall not include words that are struck through, underscored, or in boldface type. The governing authority shall be responsible for ensuring that the proposition is comprised of simple, unbiased, concise, and easily understood language.
- B. The secretary of state shall be responsible for ensuring that the proposition complies with the requirements of this Section does not exceed two hundred words in length, does not include words that are struck through, underscored, or in boldface type, and is in the form of the question."
