Establishes job order contracting as an alternative project delivery method applicable to deferred maintenance of public facilities by post-secondary educational institutions for certain work types

Proposed law provides a new way called "job order contracting" (JOC) for colleges and universities in Louisiana to handle building maintenance projects. Proposed law provides that JOC is for work that happens regularly but with uncertain timing and amounts. Proposed law provides that engineering firms, architectural firms, and contractors must be licensed by their respective Louisiana state boards to perform JOC work. Present law requires competitive bidding for public projects, but proposed law provides an alternative process for these maintenance projects. Proposed law provides that schools must create committees to review contractor qualifications based on experience, ability to finish work on time, past projects, and specific needs. Proposed law provides that JOC contracts last two years with a possible extension of up to three more years. Proposed law provides that both the school and contractor must sign each job order, and contractors must provide payment bonds. Proposed law provides that it will override conflicts in present law.
