SPECIAL DAY/WEEK/MONTH. Designates Monday, April 14, 2025, as Better Together-Children's Advocacy Centers and Court Appointed Special Advocate Day in Louisiana.

2	To designate Monday, April 14, 2025, as Better Together-Children's Advocacy Centers and
3	Louisiana Court Appointed Special Advocate Day in Louisiana.
4	WHEREAS, Louisiana's Children's Advocacy Centers and Louisiana Court
5	Appointed Special Advocate (CASA) programs have made valuable contributions to the
6	state and have helped to make it a better place for children and families; and
7	WHEREAS, the month of April has been designated National Child Abuse
8	Awareness Month, and studies show that one in ten children will experience sexual abuse
9	before the age of eighteen; and
10	WHEREAS, Louisiana's Children's Advocacy Centers provide services to over seven
11	thousand children each year for cases involving physical abuse, neglect, sexual abuse,
12	human trafficking, and children who have witnessed domestic violence and homicide; and
13	WHEREAS, each year, over five thousand children in the state experience abuse or
14	neglect, ushering them into dependency of the court and foster case services; and
15	WHEREAS, Louisiana's Children's Advocacy Centers reach over forty-five thousand
16	professionals and community members annually through education and awareness efforts
17	for the prevention, identification, and reporting of child abuse; and
18	WHEREAS, the purpose of Louisiana's Children's Advocacy Centers is to provide

every child victim with a comfortable, child-friendly environment for forensic interviewing,
 victim advocacy, mental health, and other services to reduce further trauma to the child and
 promote healing; and

WHEREAS, Louisiana's Children's Advocacy Centers work with multidisciplinary
teams of child abuse professionals to coordinate child abuse investigations and interventions,
including district attorneys, Department of Children and Family Services, CASA programs,
law enforcement agencies, mental health providers, and victim advocates; and

8 WHEREAS, Louisiana's Children's Advocacy Centers use evidence-based practices 9 to support the well being of children, and research has demonstrated that these programs 10 improve outcomes for children, reduce trauma for families, and save taxpayers money; and

WHEREAS, the Louisiana Alliance of Children's Advocacy Centers is the state
chapter established for the empowerment, collaboration, and advocacy of Louisiana's
Children's Advocacy Centers and provides a wide range of critical services to local centers;
and

WHEREAS, Louisiana's Children's Advocacy Centers are a part of a network of nine hundred centers across the nation that serve over three hundred fifty thousand children annually, with eleven centers fully accredited with members in good standing with the National Children's Alliance and three centers on the path to national accreditation; and

WHEREAS, Louisiana CASA is the statewide association for the eighteen local
 CASA programs that raise awareness of the need for CASA across our state and provide
 support, training, resources, and oversight to maintain high-quality programs that serve
 children's best interest; and

- WHEREAS, the mission of CASA is to give every child who is a victim of abuse or
 neglect an opportunity to thrive and establish permanence; and
- WHEREAS, the local CASA programs work in courtrooms across all forty-two
 judicial districts and advocate for our state's most vulnerable children; and
- WHEREAS, CASA programs in Louisiana, in association with the National CASA
 Association, speak for the best interest of abused and neglected children; and

WHEREAS, Louisiana's Children's Advocacy Centers and Louisiana CASA serve
a vital function on a daily basis to protect and advocate for Louisiana's most vulnerable

1 population.

2 THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana does hereby designate Monday, April 14, 2025, as Better Together- Louisiana's Children's 3 Advocacy Centers and Court Appointed Special Advocates Day in Louisiana and does 4 hereby commend the dedication and excellent work of those agencies, their staff, and 5 6 volunteers on behalf of the citizens of Louisiana. 7 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 8 executive director of the Louisiana Alliance of Children's Advocacy Centers and the 9 executive director of the Louisiana Court Appointed Special Advocate.
