6	WHEREAS, through the adoption of House Resolution No. 133 of the 2005 Regular
7	Session, the House of Representatives requested that the legislative fiscal office study the
8	means and methods used to provide state dollars and other funding for the operation of
9	laboratory schools around the state, including but not limited to issues concerning equity and
10	fairness in funding methods and amounts; and
11	WHEREAS, pursuant to House Resolution No. 133, the legislative fiscal office
12	conducted a study and provided a report to the House Committee on Education in March
13	2006; thereafter, pursuant to Senate Concurrent Resolution No. 137 of the 2012 Regular
14	Session, the legislative fiscal office provided an updated report to the House and Senate
15	committees on education in February 2013; and
16	WHEREAS, there is a need to update the study, findings, and options contained in
17	the 2013 report.
18	THEREFORE, BE IT RESOLVED that the House of Representatives of the
19	Legislature of Louisiana does hereby urge and request the legislative fiscal office to update
20	the report issued in February 2013 pursuant to Senate Concurrent Resolution No. 137 of the
