8 lose any rights of subrogation for claims paid under the applicable insurance policy
9 for the recovery of any sum in excess of the first fifteen one hundred thousand
10 dollars of bodily injury and the first twenty-five one hundred thousand dollars of
11 property damages.

12 (2) In claims where no suit is filed, the claimant's insurer shall have all rights 13 to recover any amount paid by the claimant's insurer on behalf of the insured for the 14 recovery of any sum in excess of the first fifteen <u>one hundred</u> thousand dollars of 15 bodily injury and the first twenty-five <u>one hundred</u> thousand dollars of property 16 damages.
