<u>Present law</u> establishes the Empowering Families to Live Well Louisiana Council within the Dept. of Children and Family Services.

Present law provides for the membership, duties, and functions of the council.

<u>Proposed law</u> reduces the number of members on the council and the number of required meetings.

<u>Proposed law</u> changes a co-chair of the council <u>from</u> a member of the Senate appointed by the Senate president <u>to</u> the chair of the Senate Committee on Health and Welfare, or his designee.

<u>Proposed law</u> moves the date the implementation plan is required to be submitted to the Senate and House committees on health and welfare <u>from</u> June 30, 2019 to June 30, 2026.

Effective upon signature of the governor or lapse of time for gubernatorial action.

(Amends R.S. 51:1057(B)(24) and (30), (C)(1), (D)(4), and (H); repeals R.S. 51:1057(B)(13), (14), (17), (23), (25), and (29))
