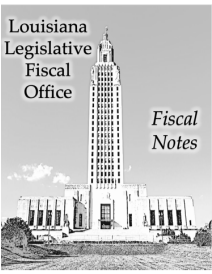

Provides relative to electronic payment processing services utilized by state entities

Current law requires the Treasurer to publish, at least annually, a list of approved credit cards and debit cards by card organization brand by which any state entity will be authorized to accept payment of any charge or payment the state entity is authorized to collect. Proposed law changes the time requirement from at least annually to at least biannually.
