SENATE RESOLUTION NO. 32

CONDOLENCES. Expresses sincere and heartfelt condolences upon the passing of Judge Jules D. Edwards III.

1	A RESOLUTION
2	To express the sincere and heartfelt condolences of the Senate of the Legislature of
3	Louisiana upon the passing of Judge Jules D. Edwards III.
4	WHEREAS, Lafayette City Court Judge Jules D. Edwards III passed away Tuesday,
5	October 15, 2024, at the age of 66, leaving behind a legacy of service, dedication, and
6	justice; and
7	WHEREAS, a native of New Orleans, Judge Edwards dedicated more than three
8	decades of his life to serving the people of Lafayette, first as a judge of the 15th Judicial
9	District Court from 1993 to 2020, and most recently as a judge of the Lafayette City Court,
10	from January 1, 2023, until his passing; and
11	WHEREAS, Judge Edwards served as Chief Judge of the 15th Judicial District Court
12	from 2001 to 2003, during which time he was a pioneer in establishing drug courts and
13	re-entry courts, placing emphasis on rehabilitation and providing second chances for those
14	within the justice system; and
15	WHEREAS, prior to judicial service, Judge Edwards was a well-known, successful
16	attorney who made significant contributions serving in various roles, including as a partner
17	at Edwards and Edwards Law Offices, an indigent defender attorney, an assistant district
18	attorney, and counsel to the Louisiana Senate's Select Committee on Crime and Drugs; and

1	WHEREAS, Judge Edwards was inducted into the Louisiana Justice Hall of Fame
2	in 2013 in recognition of his long-standing service and commitment to justice, and he was
3	the first African-American judge elected to the Lafayette City Court, where he broke barriers
4	and served as an inspiration to many; and
5	WHEREAS, in addition to his judicial career, Judge Edwards was a leader within the
6	legal community, serving as president of the Louisiana District Judges Association from
7	2014 to 2015, and as chairman of the Louisiana Judiciary Commission from 2015 to 2016,
8	where he implemented major reforms to judicial oversight and procedure; and
9	WHEREAS, Judge Edwards also contributed to public policy through his work with
10	the Louisiana Sentencing Commission from 2011 to 2018, where he helped to guide uniform
11	sentencing policies across the state, and he proudly served on various councils, including the
12	Advisory Council on Heroin and Opioid Prevention and Education, the Louisiana Drug
13	Policy Board, and since 2021, he was a member of the DWI-Task Force; and
14	WHEREAS, Judge Edwards was dedicated to educating his peers, and served as
15	Louisiana's Judicial Outreach Liaison, where he taught judges how to handle impaired
16	driving cases and sought to ensure that best practices and fairness were promoted across the
17	judiciary; and
18	WHEREAS, Judge Edwards' dedication to service was not limited to the courtroom;
19	in 1977, he enlisted in the United States Marine Corps Reserve and later served in the
20	Louisiana National Guard from 1981 until 2007, where he served in the infantry, artillery,
21	and Judge Advocate General's Corps; and
22	WHEREAS, he proudly served as the 256th Infantry Brigade's Inspector General and
23	the State Judge Advocate; and
24	WHEREAS, his distinguished military career ended on March 15, 2007, when he
25	retired from the Louisiana National Guard and was honored and recognized as the best Staff
26	Judge Advocate in the United States at that time; and
27	WHEREAS, Judge Edwards earned his undergraduate and law degrees from Loyola
28	University in New Orleans, a Master of Public Administration from Louisiana State
29	University, and a Master of Strategic Studies from the United States Army War College,
30	exemplifying a lifelong commitment to learning and service; and

1	WHEREAS, throughout his life, Judge Edwards was deeply committed to his family,
2	including his wife, Orida, his sons, Jules IV and Julien, and his daughter, Juliesa; and his
3	grandson, Julian Jr., and lived by the motto "Dare to Dream", which inspired all those who
4	knew him; and
5	WHEREAS, Judge Edwards' passing represents a profound loss to the Lafayette
6	community, the legal profession, and the state of Louisiana, but his legacy of service,
7	fairness, and dedication to helping others will continue to inspire and impact lives for
8	generations to come.
9	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
10	does hereby extend sincere and heartfelt condolences to the family and friends of Judge Jules
11	D. Edwards III upon the occasion of his passing.
12	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to Orida
13	Broussard Edwards.
