<u>Present law</u> (R.S. 33:9097.9) created the Shenandoah Estates Crime Prevention and Improvement District in East Baton Rouge Parish.

<u>Present law</u> provides that the district is governed by a 9-member board of commissioners composed as follows:

- (1) The President of the Shenandoah Estates Homeowners' Association, Inc.
- (2) Four members appointed by the board of directors of the association.
- One appointed by the mayor-president of EBRP from a list of nominations submitted by the association.
- (4) One member appointed by the member of the governing authority of EBRP whose council district encompasses all or the greater portion of the area of the district from a list of nominations submitted by the association.
- One member appointed by the member of the La. House of Representatives whose district encompasses all or the greater portion of the area of the district.
- (6) One member appointed by the member of the La. Senate whose district encompasses all or the greater portion of the area of the district.

<u>Proposed law</u> retains <u>present law</u> but transfers the appointing authority given to the mayor-president of EBRP to the mayor of the city of St. George. Retains provisions of <u>present law</u> requiring that the nominee for the board of commissioners be from a list of nominations submitted by the association.

Effective August 1, 2025.
